**Update to FY25 Guidance**

WiseTech Global Ltd (WiseTech, The Company, ASX:WTC) today provides an update to its FY25 guidance originally announced to the market at its FY24 results on 21 August 2024.

Since his appointment on 24 October 2024, Interim CEO Andrew Cartledge and the Board, in consultation with Richard White, have reviewed the progress of the Company's breakthrough products, CargoWise Next, Container Transport Optimization and ComplianceWise.

ComplianceWise was released in 1Q25 as expected, and the release of CargoWise Next is broadly on track. As a result of distractions flowing from the recent media attention and the organizational changes that have subsequently been implemented, the commercial launch of Container Transport Optimization has been delayed. It is now expected to launch in the second half of FY25, resulting in a delay to anticipated revenue. WiseTech considers it appropriate to update its FY25 guidance.

Importantly, the Company's expectations of the long-term value these products will create for WiseTech customers remain unchanged. An update on all the breakthrough products will be provided at WiseTech's Investor Day on 3 December 2024. In addition, WiseTech is seeking to mitigate the revenue delay through other significant initiatives which are also expected to have long-term benefits for WiseTech and its customers.

Subject to the assumptions set out in WiseTech's FY24 results, the Company now anticipates FY25 revenue of A\$1,200 million–A\$1,300 million representing revenue growth of 15%–25% versus FY24 and EBITDA of A\$600 million–A\$660 million representing EBITDA growth of 21%–33% versus FY24. The Company's full year EBITDA margin is expected to be 50%–51%.
