Oversubscribed SPP Closes Early

Rox Resources Limited (ASX: RXL) ("**Rox**" or "**the Company**") is pleased to provide an update on its Share Purchase Plan ("**SPP**") announced on Wednesday, 13 November 2024.

The Company intended to raise up to a maximum of \$1 million under the SPP but has received valid applications from eligible shareholders totalling approximately \$1.74 million, exceeding the target amount under the SPP.

Given the significant early demand under the SPP, the directors of the Company have determined to close the SPP early at 12:00pm (AWST) today.

The Board will, in its absolute discretion, scale back applications to the extent and in the manner it sees fit, on a first come first serve basis and taking into account the other factors detailed in the SPP offer booklet dated 22 November 2024.

The Company advises that any further applications received under the SPP will not be accepted. Excess application monies will be refunded to applicants under the terms and conditions of the SPP offer booklet.
