

## RESULTS OF ANNUAL GENERAL MEETING

In accordance with Listing Rule 3.13.2 the directors of Unith Ltd (**UNT:ASX or the Company**) advise that the following resolutions put to shareholders were carried by a poll at the Annual General Meeting of the Company held earlier today:

1. *“That, for the purposes of section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Company’s annual financial report for the financial year ended 30 June 2024.”*
2. *“That, for the purposes of clause 12.3 of the Constitution and ASX Listing Rule 14.4, Sytze Voulon retires and, being eligible, is re-elected as a Director.”*
3. *“That, for the purposes of clause 12.3 of the Constitution and ASX Listing Rule 14.4, Gary Cox retires and, being eligible, is re-elected as a Director.”*
4. *“That, for the purposes of ASX Listing Rule 7.1A, approval is given for the Company to issue up to that number of Equity Securities equal to 10% of the issued capital of the Company (at the time of the issue) calculated in accordance with the formula prescribed in ASX Listing Rule 7.1A.2 and on the terms and conditions set out in the Explanatory Statement.”*
5. *“That, the issue of performance rights and underlying performance shares in the Company under the Company’s Employee Performance Rights Share Plan, the terms and conditions of which are summarised in the Explanatory Memorandum accompanying this Notice, be approved as an exception to ASX Listing Rule 7.1 in accordance with exception 13(b) of ASX Listing Rule 7.2.”*
