### RESULTS OF 2024 ANNUAL GENERAL MEETING

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the *Corporations Act 2001* (Cth), (the **Act**) the results of the Annual General Meeting (**AGM**) of The Star Entertainment Group Limited held on Thursday, 28 November 2024 are set out below.

All resolutions put to the AGM were decided by way of poll.

Item 2: **Election of Mr Peter Hodgson as a Director** – resolution passed (91.33% For)

Item 3: **Remuneration Report** – resolution passed (56.94% For)

Item 4: **One-Off Grant of Performance Rights to Mr Steve McCann** – resolution passed (72.81% For)

Item 5: **Approval of potential retirement benefits for Mr Steve McCann** – resolution passed (61.23% For)

In relation to Item 3: Remuneration Report, as more than 25% of the votes cast were against the resolution, this constitutes a 'first strike' for the purposes of the Act.

The total number of valid proxy votes and direct votes received in respect of each item that was put to the meeting are set out in the attached report.
