

## 2024 AGM Results and Chairman

**SYDNEY** (Friday, 29 November 2024) – In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act, Centuria Capital Group (**ASX: CNI**) releases the attached report, which sets out the details of the total number of votes cast on the poll and the total number of proxy votes received in respect of each resolution put to the Annual General Meeting (**AGM**) held today, 29 November 2024.
