### TRADING HALT REQUEST – ASX CODE: DRO

**DroneShield Limited** (ACN 608 915 859) (ASX Code: **DRO**) (the **Company**) requests an immediate trading halt for its ordinary shares under Listing Rule 17.1 be granted by ASX from the commencement of trading on Thursday, 5 December 2024.

In accordance with Listing Rule 17.1, the Company provides the following information:

**Reason for trading halt** – the trading halt is requested pending an announcement by the Company in relation to additional information requested by the ASX to the announcement dated 5 December 2024 entitled **\$8.2 million European contract**, which will be released as an updated announcement (the **Updated Announcement**).

**Duration of the trading halt** – the Company anticipates that the trading halt will remain in place until the earlier of the Company releasing the Updated Announcement to the market or commencement of trading on Monday, 9 December 2024.

**Termination of the trading halt** – the Company anticipates that the trading halt will cease upon the earlier of the Company releasing the Updated Announcement to the market or commencement of trading on Monday, 9 December 2024.

**Further information** – the Company is not aware of any reason why the trading halt should not be granted or any other information necessary to inform the market or ASX about the trading halt.

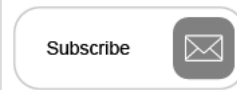

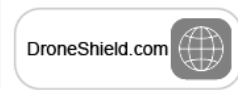
