JPMorgan Asset Management (Australia) Limited – mFund – Notice of Closure

As per the ASX Participant Notice on 28 November 2023, the ASX has decided to discontinue the Managed Fund Settlement Service (mFund) <https://asxonline.com/public/documents/asx-managed-fund-settlement-service--mfund-/mfund-wind-down-and-closure.html>.

In alignment with the ASX's decision, the below funds will be removed from the mFund service ahead of the closure of the service.

How can you redeem your holdings?

Please note for listed products with similar investment strategies and objectives to JPM02 and JPM06, you may wish to consider the JPMorgan Global Research Enhanced Index Equity (Hedged) Active ETF (ASX ticker: JRHG) and the JPMorgan Income (Hedged) Active ETF (CBOE ticker: JPIE).

A blackout period for any new applications will apply from the date of this letter. The final day for redeeming your fund holding(s) is **23 June 2025**. After this date we will redeem your holding(s) and pay the proceeds to your nominated bank account. In the event your details are not up to date, please contact LINK Fund Solutions Pty Limited, as the Registrar, on 1800 576 100.
