### 1H25 RESULTS

Count Limited (**Count** or the **Company**) (**ASX:CUP**) today issued its 1H25 financial results for the six months ending 31 December 2024.

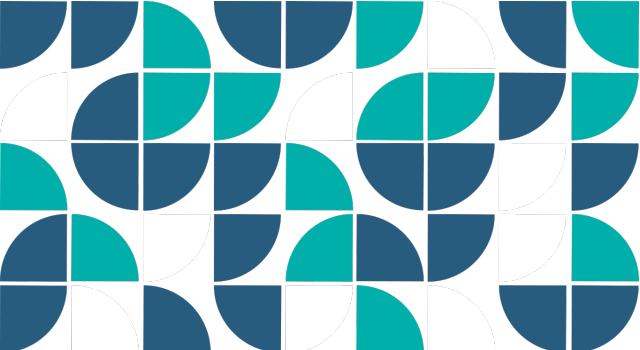
Key highlights include:

- Statutory profit attributable to Count shareholders of **\$4.0m**, an increase of **+541%** on the Prior Corresponding Period (PCP)
- Statutory Revenue of **\$73.9m**, an increase of **+54%** compared to the PCP
- Underlying Earnings Before Interest, Tax and Amortisation (EBITA) of **\$13.9m**, an increase of **+141%** on PCP
- Underlying EBITA Margin increased to 19%, compared to the PCP of 13%
- Funds Under Advice (FUA) of **\$36.2b**, an increase of **+6%** on 30 June 2024 balance
- Funds under Management (FUM) of **\$3.5b**, an increase of **+12%** on 30 June 2024 balance
- Significant expansion of the Services segment revenue to **\$15.6m**, an increase of **+404%** on PCP
- Disciplined execution of our acquisition strategy with **6** transactions successfully completed during the period
- Successful completion and closure of the Diverger integration program, delivering annualised run rate cost synergies of more than **\$4m** in FY25
- More than **155,000** clients served in the period
- An interim dividend of **1.75** cents per share, an increase of **+17%** on PCP
