Titomic Limited (ASX: TTT) ('Titomic' or 'Company'), a global leader in advanced additive manufacturing and cold spray technology, is pleased to release its financial results for the half-year ended 31 December 2024.

Highlights during 1HFY2025:

- **Successful AUD 30 million capital raise** to fuel U.S. expansion and global growth.
- **Strategic U.S. expansion:** Secured Huntsville, Alabama, as the foundation for U.S. operations, solidifying our presence in the world's largest defense and aerospace market.
- **Leadership Reinforcement:** Appointment of industry veterans, including Jim Simpson (CEO/Managing Director), Dr. Patricia Dare (President, U.S.), and Sarah Neeley (COO, U.S.).
- **U.S. Market Penetration:** Secured **USD 577K in aerospace and defense purchase orders**, with total project orders surpassing AUD 1 million—laying the groundwork for sustained momentum.
- **Breakthrough Sales:** Expanded cold spray adoption across multiple sectors, including:
 - **NAVSEA (U.S. Navy), University of North Texas, Effe, Hydraulex, and Deakin University.**
 - Advancing collaborations with top-tier defense primes and industrial leaders.
- **Pioneering Innovation:** Developed an **augmented reality solution** for low-pressure cold spray (D523) and a prototype **cold spray backpack solution**—expanding accessibility and usability.
- **Strengthened Industry Standards & Certifications:**
 - **DNV ProGRAM participation** to define **cold spray standards for oil & gas applications.**
 - **Co-development of AMS 7057**, the next-generation aerospace cold spray standard.
- **Revenue Surge:** Customer sales revenue climbed **to AUD 3.7 million**, reflecting **61% growth YoY** (compared to AUD 2.3 million in the previous half-year).
