The Company advises that Resolution 1 was amended at the Meeting to ratify only the issue of the Tranche 1 Placement Shares issued under the Company's ASX Listing Rule 7.1 placement capacity (147,221,350 Shares). The Company intends to seek shareholder approval to ratify the issue of the remaining Tranche 1 Placement Shares issued under the Company's ASX Listing Rule 7.1A placement capacity (98,492,935 Shares) at the Company's forthcoming Annual General Meeting.
