## REGION 6 SYDNEY BUS SERVICES CONTRACT UPDATE

Kelsian Group Limited (ASX:KLS) (**'Kelsian'**) today advises that Transport for New South Wales (**'TfNSW'**) has made the decision to enter direct negotiations with Transit Systems West Pty Ltd<sup>i</sup>; the incumbent operator of Sydney Region 6 bus services; for a new short-term contract for the provision of public bus services in the inner west of Sydney, known as Region 6. Transit Systems West<sup>i</sup> has operated services under the existing Region 6 bus services contract for TfNSW since July 2018, with contract revenue in FY2025 expected to be approximately \$219 million annual revenue for the operation and maintenance of 566 buses from four depots, and directly employing approximately 1,350 employees. If negotiations are successful, Kelsian subsidiary, Transit Systems, will continue to operate Region 6 for a further period from 30 June 2026 when the current contract expires.<sup>ii</sup>

TfNSW has advised that if the parties are not able to reach agreement on a new short-term contract by mid-2025, TfNSW will proceed with a competitive tender process for Region 6, as previously planned.

**Kelsian Managing Director and Group Chief Executive Officer, Clint Feuerherdt** said: "We welcome the early opportunity to negotiate directly with Transport for NSW for a new short-term contract and I look forward to working closely with the team on the terms of the new contract. I am proud of Transit Systems' excellent track record in being regularly ranked as one of the best operators for on time running and other operational contract performance measures throughout the majority of the contract term."
