Middle Island Resources Limited (**ASX:MDI**) wishes to advise that Resolutions 1 and 2 as detailed in the Notice of General Meeting dated 7 March 2025 were considered, passed and carried on a poll with the requisite majority at that meeting held today.


Messrs Peter Thomas and Bruce Stewart each voluntarily resigned as directors of MDI, with agreement that the resignations take effect immediately after the appointment of Messrs Daniel Raihani and Bill Richie Yang to the board. Consequently, Resolutions 3 and 4 (to remove Messrs Thomas and Stewart as directors of the Company) were not considered at the meeting.

As a consequence of Resolutions 1 and 2 being passed, Messrs Raihani and Yang were appointed as directors of MDI, effective as of today's date.
