NOTICE IS HEREBY GIVEN that the 2025 Annual Meeting of Stockholders (**Annual Meeting**) of GQG Partners Inc., a Delaware USA corporation (**Company**) (**ASX:GQG**), will be held at 9:00 am (Australian Eastern Standard Time) on Thursday 22 May 2025/7:00 pm (U.S. Eastern Daylight Time) on Wednesday 21 May 2025.

The Board of Directors (**Board**) of GQG Partners Inc. (**Company**) is soliciting proxies for use at the 2025 Annual Meeting of Stockholders (**Annual Meeting**) to be held at 9:00 am (Australian Eastern Standard Time) on Thursday 22 May 2025/7:00 pm (U.S. Eastern Daylight Time) on Wednesday 21 May 2025 and at any adjournment or postponement of the Annual Meeting.

The Annual Meeting will be held as a virtual event, which will be conducted online. Owners of shares of Common Stock of the Company (**Shares**) and record holders of CHESS Depositary Interests (**CDIs**) will be able to watch and participate in the Annual Meeting virtually at https://meetings.openbriefing.com/GQG25.

QUESTIONS AND ANSWERS ABOUT THE ANNUAL MEETING AND VOTING

What is the purpose of the Annual Meeting?

At the Annual Meeting, record holders of Shares (**Stockholders**) and holders of CDIs are invited to act upon the matters outlined in the Notice of Annual Meeting of Stockholders (**Notice of Meeting**) being:

- Item 1: Election of Class I Director Mr. Bryan Weeks
- Item 2: Any other business as may be properly presented at the Annual Meeting or any

adjournment or postponement thereof

Who is entitled to vote at the Annual Meeting?

Only those Stockholders of record or holders of CDIs at 7:00 pm (Australian Eastern Daylight Time) on Monday 31 March 2025/4:00 am (U.S. Eastern Daylight Time) on Monday 31 March 2025 (Record Date) will be entitled to receive notice of and to vote at the Annual Meeting and any adjournment or postponement thereof. CDI holders as of the Record Date are entitled to receive notice of and attend the Annual Meeting and may instruct CHESS Depositary Nominees Pty Ltd (CDN) to vote at the meeting by following the instructions on the CDI Voting Instruction Form or by voting online at https://au.investorcentre.mpms.mufg.com.

As of the Record Date, there were 2,955,290,756 Shares outstanding, of which 843,291,165 Shares are represented by CDIs outstanding. Each CDI represents an interest in one Share. Record holders of Shares are entitled to one vote for each Share held as at the Record Date, and holders of CDIs are entitled to direct CDN to vote one vote for every CDI held by such holder as at the Record Date, as further set out below.

Will any investors be excluded from voting on the proposal to be presented at the Annual Meeting?

No.

How do I use the online platform in connection with the Annual Meeting?

To facilitate Stockholder and CDI holder participation in the Annual Meeting, Stockholders and CDI holders will have the opportunity to participate in the Annual Meeting through the online platform at https://meetings.openbriefing.com/GQG25. If you use the online platform, you will be able to view the Annual Meeting live and submit questions online during the Annual Meeting.

More information about how to use the online platform (including how to vote and submit questions online during the Annual Meeting) is available in the Virtual Annual Meeting Online Guide, which has been lodged with the ASX and is available at https://investors.gqg.com/investor-centre. If you intend to use the online platform, we recommend that you ensure the online platform works on your device before the Annual Meeting. Further instructions are provided in the Online Guide.

Technical difficulties may arise during the course of the Annual Meeting. The Chair of the Annual Meeting has discretion as to whether and how the Annual Meeting should proceed in the event that a technical difficulty arises. In exercising his or her discretion, the Chair of the Annual Meeting will have regard to the number of Stockholders and CDI holders impacted and the extent to which participation in the business of the Annual Meeting is affected. Where he or she considers it appropriate, the Chair of the Annual Meeting may continue to hold the Annual Meeting and transact business, including conducting a poll and voting in accordance with valid proxy instructions. For this reason, security holders are encouraged to vote or submit a proxy in advance of the Annual Meeting, even if they plan to attend the Annual Meeting online.

What are my voting rights?

Record holders of Shares are entitled to one vote for each Share held as at the Record Date. Holders of CDIs are entitled to direct CDN to vote one vote for every CDI held by such holder as at the Record Date. Therefore, as of the Record Date, a total of 2,955,290,756 votes are entitled to be cast at the Annual Meeting.

How many Shares and CDIs must be present to hold the Annual Meeting?

In accordance with Section 2.4 of the Company's Amended and Restated Bylaws, the holders of at least half of the capital stock issued and outstanding and entitled to vote thereat, as of the Record Date, must be present in person or by proxy at the Annual Meeting in order to hold the meeting and conduct business.

This is called a quorum.

What is a proxy?

It is your designation of another person to vote stock you own. That other person is called a proxy. If you designate someone as your proxy in a written document, that document also is called a proxy or a proxy card. When you designate a proxy, you also may direct the proxy how to vote your Shares. We refer to this as your "proxy vote".

What is the difference between a Stockholder of record and a record holder of CDIs?

If you own Shares registered directly in your name with our U.S. transfer agent, Equiniti Trust Company, LLC (EQ), you are considered the Stockholder of record with respect to those Shares. As a Stockholder of record, you have the right to designate a proxy to vote your Shares or to vote virtually at the Annual Meeting.

CDN is the Stockholder of record for all Shares beneficially owned by holders of CDIs. Each CDI holder as at the Record Date is entitled to direct CDN to vote one vote for every CDI held by such holder. Such CDI holders are entitled to receive notice of and to attend the Annual Meeting and any adjournment or postponement of the Annual Meeting and may instruct the Company's CDI depositary, CDN, to vote the Shares underlying their CDIs.

How do I vote my Shares or CDIs of GQG Partners Inc.?

If you are a Stockholder of record or a record holder of CDIs, you may vote in advance pursuant to the instructions below. Stockholders of record may also vote during the Annual Meeting by attending and voting online using the online platform.

Valid proxy cards for Shares must be received by MUFG Corporate Markets (AU) Limited no later than 9:00 am (Australian Eastern Standard Time) on Tuesday 20 May 2025/7:00 pm (U.S. Eastern Daylight Time) on Monday 19 May 2025.

Valid CDI Voting Instruction Forms must be received by MUFG Corporate Markets (AU) Limited (the Company's CDI registry) no later than 9:00 am (Australian Eastern Standard Time) on Monday 19 May 2025/7:00 pm (U.S. Eastern Daylight Time) on Sunday 18 May 2025.

After this time, Stockholders of record will still be able to vote by voting during the Annual Meeting by using the online platform.

Can I submit questions during or in advance of the Annual Meeting?

Yes. Stockholders will have the opportunity to submit questions during the Annual Meeting using the online platform. Please refer to the Virtual Annual Meeting Online Guide accompanying this Proxy Statement for information on how to submit a question during the meeting.

Stockholders also may submit questions in advance of the Annual Meeting by submitting questions up to 72 hours ahead of the Annual Meeting by visiting https://au.investorcentre.mpms.mufg.com. You will need your Securityholder Reference Number (SRN) or Holder Identification Number (HIN).

If multiple similar questions are received, they may be grouped together, rather than put to the Annual Meeting individually, to ensure there is time to consider as many stockholder questions as possible. This means your question may not be put to the Annual Meeting verbatim.

Please note that there may not be sufficient time available during the Annual Meeting to address all the questions raised and written responses will not be sent to stockholders. Inappropriate questions will not be put to the meeting (for example, questions that are offensive, are not pertinent to the Company's business, contain explicit language or are determined by the Company to be potentially defamatory).

What does it mean if I receive more than one printed set of proxy materials?

If you receive more than one printed set of proxy materials, it means that you hold Shares or CDIs registered in more than one account. To ensure that all of your Shares and CDIs are voted, please submit proxy cards and / or CDI Voting Instruction Forms for all of your Shares and CDIs.

How can I attend the Annual Meeting using the online platform?

Stockholders and CDI holders may watch and participate in the Annual Meeting virtually via the online platform by using:

 a desktop or laptop computer (or other device with a compatible browser connected to the internet) – online at https://meetings.openbriefing.com/GQG25. To participate in the Annual Meeting online as a Stockholder or CDI holder, please log in to the Annual Meeting by:

- 2. Reading and accepting the terms and conditions before proceeding to click the 'Register and Watch Annual Meeting' button.

Can I vote my Shares or CDIs at the Annual Meeting?

If you are a Stockholder of record, you may vote your Shares online during the Annual Meeting by following the instructions available on the Virtual Annual Meeting platform.

If you are a record holder of CDIs, you must vote your CDIs in advance of the Annual Meeting. Please refer to "How do I vote my Shares or CDIs of GQG Partners Inc.?" above for more information.

To participate in the Annual Meeting online, please follow the instructions outlined above in "How do I use the online platform in connection with the Annual Meeting?"

We recommend that you submit your vote before the Annual Meeting as described above. If you are a Stockholder of record and submit your vote before the Annual Meeting and later decide to vote online at the Annual Meeting, the vote you submit at the Annual Meeting will override your previous vote.

What is the voting requirement to approve the proposal included in the Notice of Meeting?

Item 1 - Election of Class I Director - Mr. Bryan Weeks

You may vote "FOR" or "WITHHOLD" on Item 1.

The vote required to approve the foregoing proposal is a "FOR" vote of the holders of a plurality of the voting power of the Shares and CDIs that are present in person or represented by proxy at the Annual Meeting and entitled to vote on such proposal.

Under ASX Listing Rule 14.2.1, a proxy card must allow Stockholders to vote for a resolution, against a resolution or to abstain from voting on a resolution. In accordance with the provisions of the General Corporation Law of the State of Delaware, the Amended and Restated Bylaws of the Company provide that directors shall be elected to the Board of Directors by a plurality of the votes cast (i.e., the person(s) elected will be those with the most affirmative votes received among votes properly cast at the Annual Meeting or by proxy). To enable this, ASX has granted the Company a waiver from ASX Listing Rule 14.2.1 to permit the Company not to provide an option for holders of CDIs to vote against a resolution to elect a director in a CDI Voting Instruction Form. The terms of the waiver are that:

- the Company complies with the relevant Delaware laws as to the content of the proxy cards applicable to resolutions for the elections of directors,
- the notice given by the Company to CDI holders under ASX Settlement Operating Rule 13.8.9
 makes it clear that holders are only able to vote for resolutions or abstain from voting, and the
 reasons why this is the case,
- the Company releases details of this waiver to the market as part of the pre-quotation disclosure, and the terms of the waiver are set out in the management proxy circular provided to all holders of CDIs, and
- without limiting ASX's right to vary to its decision under ASX Listing Rule 18.3, the waiver from Listing Rule 14.2.1 only applies for so long as the relevant Delaware laws prevent the Company from permitting stockholders to vote against a resolution to elect a director.

Can I change my vote or revoke my proxy?

Yes. If you are a Stockholder of record, you may change your vote or revoke your proxy:

- by voting (or voting again) online, by no later than 9:00 am (Australian Eastern Standard Time) on Tuesday 20 May 2025/7:00 pm (U.S. Eastern Daylight Time) on Monday 19 May 2025;
- by submitting a later-dated proxy card to the Company's Share Registry at c/o MUFG Corporate Markets (AU) Limited, Locked Bag A14, Sydney South, NSW 1235, Australia, which must be received by MUFG Corporate Markets (AU) Limited no later than 9:00 am (Australian Eastern Standard Time) on Tuesday 20 May 2025/7:00 pm (U.S. Eastern Daylight Time) on Monday 19 May 2025;
- by sending a written notice of the revocation of your proxy to the Company's Share Registry at c/o MUFG Corporate Markets (AU) Limited, Locked Bag A14, Sydney South, NSW 1235, Australia, which must be received by MUFG Corporate Markets (AU) Limited before the time of the Annual Meeting; or
- by voting via the online platform during the Annual Meeting.

If you are a holder of CDIs and you direct CDN to vote by completing the CDI Voting Instruction Form, you may revoke those instructions by delivering to MUFG Corporate Markets (AU) Limited, no later than 9:00 am (Australian Eastern Standard Time) on Monday 19 May 2025/7:00 pm (U.S. Eastern Daylight Time) on Sunday 18 May 2025, a written notice of revocation bearing a later date than the CDI Voting Instruction Form previously sent.

Who pays for the cost of proxy preparation and solicitation?

The Company pays for the cost of proxy preparation and solicitation. We are soliciting proxies by mail. In addition, our directors, officers and regular employees may solicit proxies personally, telephonically, electronically or by other means of communication. The Company's directors, officers and regular employees will receive no compensation for their services in this regard, other than their regular compensation.

EXPLANATORY MEMORANDUM

Item 1: Election of Class I Director - Mr. Bryan Weeks

The Company's Amended and Restated Certificate of Incorporation provides that the Board of Directors shall be divided into three classes, designated Class I, Class II and Class III, as nearly equal in number as possible.

The Board proposes that Mr. Bryan Weeks, a current Class I Director whose term expires at the Annual Meeting, be elected by stockholders at the Annual Meeting as a Class I director.

If elected, the term of office of the Class I director will next expire at the annual meeting of stockholders to be held in 2028.

Mr. Weeks was appointed as a director of the Company on 19 June 2024 and is a member of the Board's Audit Committee, Risk Committee and Remuneration and Nomination Committee.

Since his appointment as director, Mr. Weeks has attended all meetings of the Board and the Committees of which he is a member.

Mr. Weeks has decades of experience contributing to the growth and success of major businesses across asset management and technology consulting. In asset management, Mr. Weeks served as the head of the Americas Institutional business at Russell Investments, a leading global investment management and solutions firm, and Chief Executive Officer at Silver Creek Capital Management, an alternative investment boutique. In technology consulting, Mr. Weeks serves on the Board of Directors for Slalom Consulting, a global technology consulting firm. Mr. Weeks also has founded and/or served on the Board of Directors of numerous other businesses, including Earth Finance, Inc., PLTgolf, Domex Superfresh, Northern Lights Capital Group and True Linksware.

Directors' recommendation for Item 1

The Directors unanimously (other than Mr. Bryan Weeks, who abstained from voting) support the election of Mr. Weeks and recommend that Stockholders vote in favour of this resolution.

Chair's voting intention for Item 1

The Chair of the Annual Meeting intends to vote all available undirected proxies in favour of this resolution.






- On the left a live webcast of the Meeting starts automatically once the meeting has commenced.

- At the bottom buttons for 'Get a Voting Card', 'Ask a Question' and a list of company documents to download

Note: If you close your browser, your session will expire and you will need to re-register. If using the same email address, you can request a link to be emailed to you to log back in.

1. Get a Voting Card

To register to vote – click on the 'Get a Voting Card' button.

This will bring up a box which looks like this.





If you are an individual or joint shareholder you will need to register and provide validation by entering your shareholder number and postcode.

If you are an appointed Proxy, please enter the Proxy Number issued by MUFG in the PROXY DETAILS section. Then click the **'SUBMIT DETAILS AND VOTE'** button.

Full Votes



2. How to ask a question

Click in the 'Question' section and type your question and click on 'Submit'.


