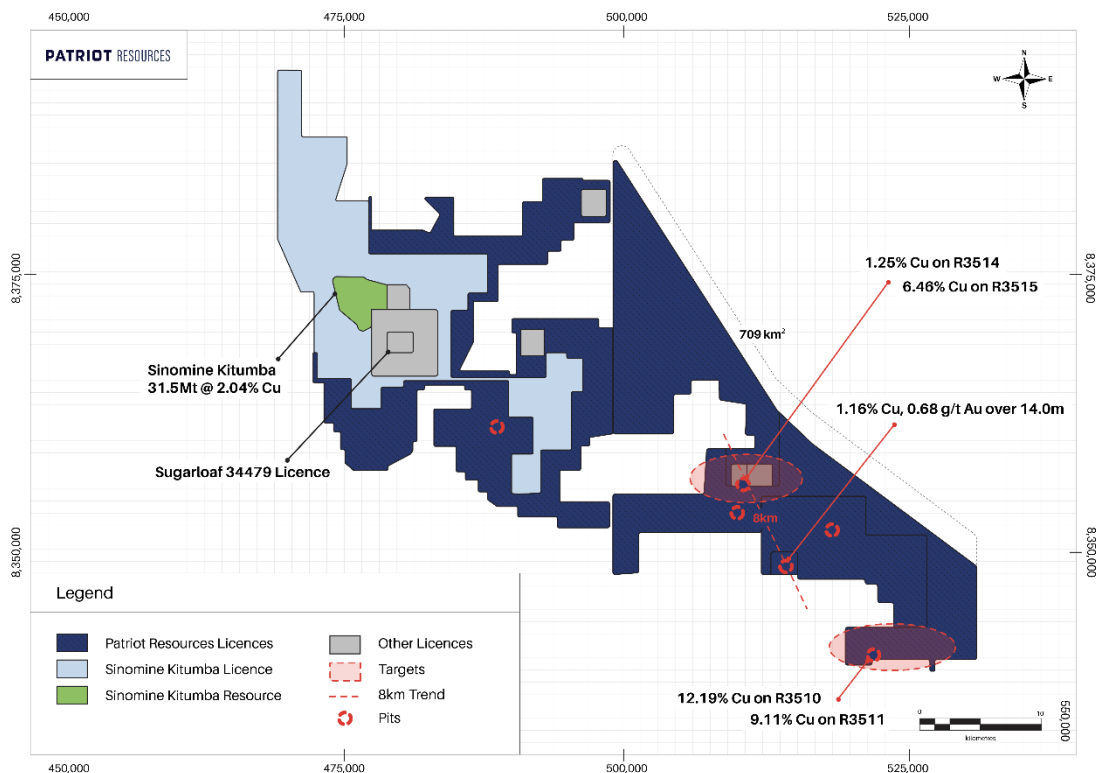
QUARTERLY ACTIVITIES REPORT 31 March 2025

The March Quarter was filled with more on-ground exploration and consolidation of our exploration acreage in the high-grade copper district of Mumbwa – which now covers 709km².

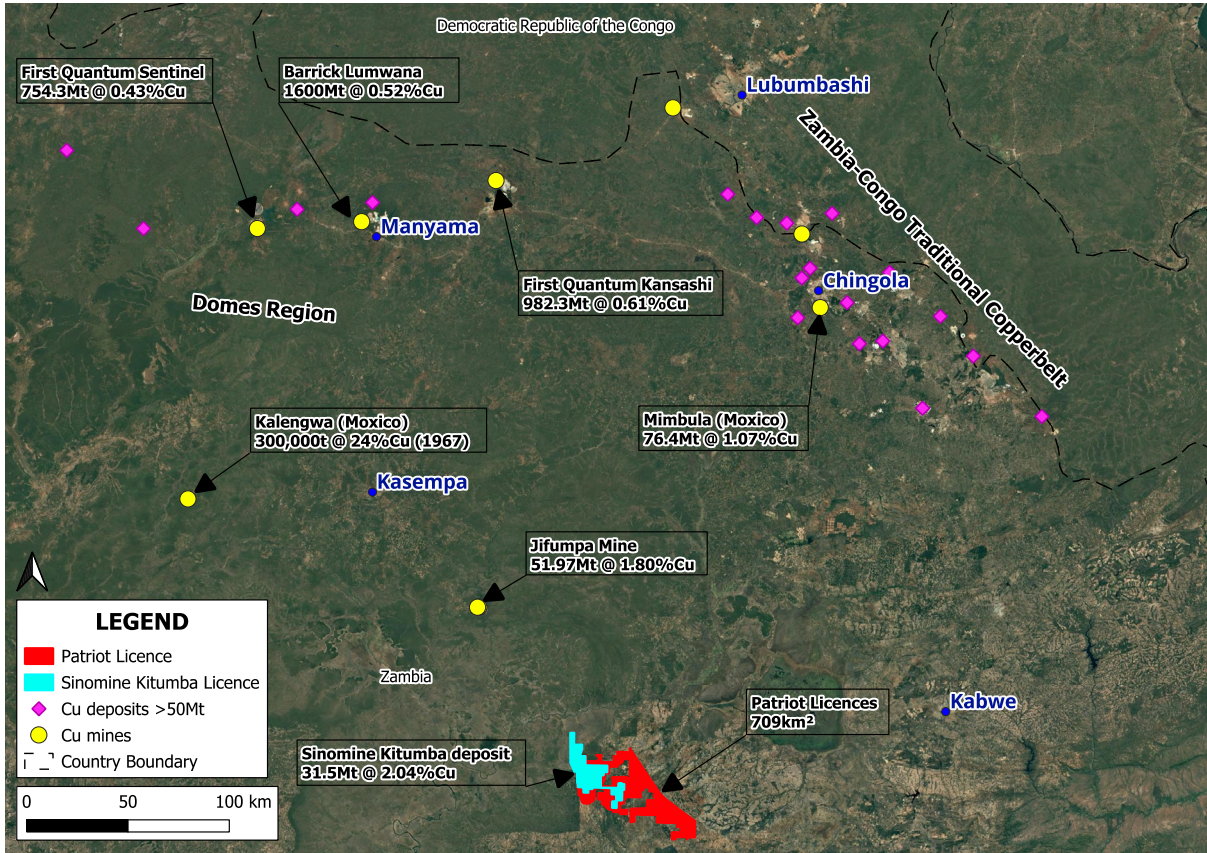
Patriot is now one of the largest land holders in region and we believe it is one of the most exciting junior African copper plays to follow.

A quick reminder of what we have announced:

- Sampled **copper** and **gold** bearing quartz-carbonate metasilstone from the south eastern face of the Katwaro Pit averaged 1.16% Cu and 0.68 g/t Au over **14.0m** including 4.45% Cu and 2.59 g/t Au over **2.0m**.
- Field mapping identifies approximately **8km** of possible strike between our Katwaro pit and one of the new copper targets, Chimban South.
- Rock samples analyzed using a portable XRF returned high grade copper readings up to **33.08% Cu (12.19% Cu ave)** at CBR South target and **17.36% Cu (6.46% Cu ave)** at Chimban South.
- Identified copper occurrences outside our licences and confirmed the copper extensions continue into our licences.
- Option to acquire 3 licences covering 450km². These licences cover 45 kms of contiguous strike along several regional structures controlling and hosting copper mineralisation within the Mumbwa Region. Patriot has already identified a number of historic artisanal copper mines within the licence area.

What's Next

The following two quarters are expected to be focussed on exploration. Our exploration team is planning to undertake:

- An aero magnetic survey
- An Induced Polarisation survey
- 5,000m RC and 4,000m Diamond Drilling to test for mineralised extensions:
 - From the historic Katwaro pit,
 - Along the 8km of potential strike between historic pits; and
 - Other copper outcrops that we have identified.

CORPORATE

Patriot held cash reserves of approximately \$499k at 31 March 2025. The Company intends to raise additional funds to carry out the 2025 drill programme.

During the Quarter, the Company received co-contributions towards the Gorman exploration programme of approximately CAD\$160k.
