The JV includes a non-exclusive, royalty-free license for each party’s software solely for developing and delivering project solutions, with separate end-user licensing terms for commercial deployments. The agreement is for an initial 12 months with provisions for extension or termination in cases of material breach or insolvency, safeguarding both parties’ interests.
