## Amended - Results of Scheme Meeting Envirosuite shareholders vote in favour of Scheme of Arrangement

**Envirosuite Limited (ASX: EVS)** refers to its announcement earlier today titled 'Results of Scheme Meeting'. Due to a clerical error, the proportion of Envirosuite Shareholders present and voting at the Scheme Meeting (either in person or by proxy) that were in favour of the Scheme Resolution was misstated and should have instead stated 90.21%.

The resolution to approve the Scheme was passed by the requisite majority of Envirosuite shareholders. For the avoidance of doubt, in summary, the voting results were:

- **99.54%** of the **votes** cast by Envirosuite Shareholders were **in favour** of the Scheme Resolution; and
- **90.21%** of Envirosuite **Shareholders present and voting** at the Scheme Meeting (either in person or by proxy) were **in favour** of the Scheme Resolution.

Further details of the valid proxies received and votes cast are attached to this announcement.
