## RESULTS OF SCHEME MEETING

Donaco International Limited (**Donaco** or the **Company**) is pleased to announce that the requisite majorities of Donaco shareholders today voted in favour of On Nut Road Limited's (**ONR**) proposed acquisition of 100% of the shares in Donaco that it does not already own via a scheme of arrangement (**Scheme**).<sup>1</sup>

### Voting results

Donaco advises that the resolution to approve the Scheme (as set out in the Notice of Meeting at Annexure D of the Scheme Booklet released on 23 June 2025) was passed by the requisite majorities of Donaco shareholders. The vote on the resolution was conducted by a poll.

In accordance with Listing Rule 3.12.2 and section 251AA of the *Corporations Act 2001* (Cth), a detailed report of the proxies received and the votes cast on the resolution to approve the Scheme is included in **Appendix 1** to this announcement.

In summary:

- 98.11% of votes cast by Donaco shareholders were in favour of the Scheme; and
- 77.50% of Donaco shareholders present and voting (in person or by proxy, attorney or corporate representative) voted in favour of the Scheme.

### Next steps

The Scheme remains subject to the approval by the Supreme Court of New South Wales (**Court**) at a hearing scheduled for Thursday, 7 August 2025 (**Second Court Hearing**) and certain other customary conditions precedent as previously announced and described in the Scheme Booklet.<sup>2</sup>

If the outstanding conditions precedent are satisfied or waived (as applicable) prior to the Second Court Hearing, and the Court approves the Scheme, DNA intends to lodge a copy of the orders of the Court with the Australian Securities and Investments Commission on Friday, 8 August 2025, so that the Scheme will become effective on that date. If this occurs, it is expected that DNA shares will be suspended from trading on the ASX with effect from close of trading on Friday, 8 August 2025.

Implementation of the Scheme is expected to occur on Tuesday, 19 August 2025.
