ASX ANNOUNCEMENT

Scheme of arrangement becomes legally effective and suspension of trading on ASX

Sydney, 7 August 2025: Domain Holdings Australia Limited (ASX:DHG) ("**Domain**") refers to the announcement made yesterday on Wednesday, 6 August 2025 and confirms that it has lodged with the Australian Securities and Investments Commission ("**ASIC**") an office copy of the orders made by the Supreme Court of New South Wales approving the acquisition of Domain by CoStar Group, Inc. (NASDAQ:CSGP) through its indirect wholly-owned subsidiary, Andromeda Australia SubCo Pty Limited, by way of scheme of arrangement ("**Scheme**").

Unless otherwise indicated, capitalised terms used in this announcement have the meaning given to them in the Scheme Booklet dated 30 June 2025.

Lodgement of Court Orders and Suspension of Trading

An office copy of the Court orders lodged with ASIC is attached to this announcement.

The Scheme is now legally effective, and it is expected that trading in Domain Shares on the ASX will be suspended from the close of trading today (Thursday, 7 August 2025).

Special Dividend

On Tuesday, 19 August 2025, Domain Shareholders will be paid a fully franked Special Dividend of 8.8 cents per Domain Share held on the Special Dividend Record Date of 7:00pm (AEST) on Tuesday, 12 August 2025.

Scheme Consideration

On the Implementation Date for the Scheme (expected to be on Wednesday, 27 August 2025), Domain Shareholders (other than Excluded Shareholders) will be paid \$4.342 cash per Domain Share (being the Scheme Consideration of \$4.43 reduced by the amount of the Special Dividend of 8.8 cents) held on the Scheme Record Date of 7:00pm (AEST) on Wednesday, 20 August 2025.

THE COURT ORDERS THAT:

1 Pursuant to section 411(4)(b) of the Corporations Act 2001 (Cth) (the Act), the scheme or arrangement between Domain Holdings Australia Limited ACN 094 154 364 (Domain) and the holders of fully paid ordinary shares in Domain other than Excluded Shareholders (as defined in the Scheme) the terms of which are contained in Attachment C to the Scheme Booklet dated 30 June 2025 (a copy of which is Exhibit 1 in the proceeding) (Scheme), as amended by order 2 below, be approved.

2 Pursuant to section 411(6) of the Act, the Scheme be amended by replacing the definition of "Excluded Shareholder" in Schedule 1 of the Scheme with the words "Excluded Shareholder means Andromeda Australia SubCo Pty Limited ACN 684 354 265".

3 Pursuant to section 411(12) of the Act, Domain be exempted from compliance with section 411(11) of the Act in relation to the Scheme.

4 These orders be entered forthwith.
