**MIXI Australia Takeover Offer for PointsBet (ASX:PBH): Notice of automatic extension**

MIXI Australia Pty Ltd (ABN 22 681 434 640) (**MIXI Australia**), a wholly-owned subsidiary of MIXI, Inc (TSE:2121), refers to its off-market takeover bid for all of the ordinary shares in PointsBet Holdings Limited (ABN 68 621 179 351) (**PointsBet**) (**Offer**). The Offer opened on 22 July 2025 and was scheduled to close on 29 August 2025, as extended by the notice of variation provided on 21 August 2025 (**Offer Period**).

On 29 August 2025, MIXI Australia's voting power in PointsBet increased to more than **50%**.

We enclose a notice pursuant to section 624(2) of the *Corporations Act 2001* (Cth) (**Corporations Act**) advising that the Offer Period has been automatically extended by 14 days so that the Offer will remain open for acceptance until 7:00pm (Melbourne time) on **12 September 2025**. MIXI Australia notes that there will be **no further extension** of the Offer Period<sup>1</sup>.

This notice has been given to PointsBet and will be provided to all other relevant persons in accordance with section 624(2) of the Corporations Act, as modified by *ASIC Corporations (Takeover Bids) Instrument 2023/683*.

This is a notice made in accordance with section 624(2) of the Corporations Act, in connection with the off-market takeover bid by MIXI Australia Pty Ltd (ABN 22 681 434 640) (**MIXI Australia**) to acquire all of the ordinary shares in PointsBet (**Offer**) as set out in its bidder's statement dated 17 July 2025 as supplemented by its supplementary bidder's statements dated 15 August 2025, 21 August 2025 and 25 August 2025 (**Bidder's Statement**). Capitalised terms in this notice have the same meaning given in the Bidder's Statement, unless the context requires otherwise.

**Automatic extension of Offer Period**

In accordance with section 624(2)(b) of the Corporations Act, MIXI Australia hereby gives notice that:

1. MIXI Australia's voting power in PointsBet increased to more than **50%** on 29 August 2025;
2. because of that event and the operation of section 624(2) of the Corporations Act, the Offer Period has been automatically extended by 14 days so that the Offer will remain open for acceptance until 7:00pm (Melbourne time) on **12 September 2025**<sup>2</sup>;
3. all references or deemed references to "29 August 2025" in the Bidder's Statement, in any previous notices and in all other instances where "29 August 2025" appears as the closing date of the Offer, are replaced with "12 September 2025".

The Offer will close at 7:00pm (Melbourne time) on 12 September 2025<sup>2</sup>.
