## **ALLAN GRAY FUNDS ON ASX MFUND SETTLEMENT SERVICE TO CLOSE**

From 2 March 2026, the following Allan Gray Funds will no longer be available through the ASX mFund Settlement Service (mFund).

Existing mFund investors can continue to buy or sell units through your stockbroker until 5pm (Sydney time) on Friday, 20 February 2026. After that, the Registry will transfer all units held through your HIN to a holding directly with the Registry. From Monday, 2 March 2026, all transacting and correspondence in relation to your investment will be through the Registry. This means you will not be able to instruct on your account for a week.

Existing mFund investors have 2 options until 20 February 2026. You should consider seeking professional financial and tax advice before making a decision.

Option 1 – Do nothing and wait for conversion to a direct holding	Option 2 – covert early to a direct holding
Take no action. Your mFund holding will be converted to a direct holding through the Registry on 2 March 2026.	Contact your broker to convert your mFund holding to a direct holding through the Registry. This conversion must be done before 20 February 2026.

Once you convert to a direct holding, Allan Gray will reach out you to collect your contact details and certain identification documentation, to comply with Australia's Anti-Money Laundering and Counter Terrorism Financing Law.

The Funds will be closed to new mFund investors from 5pm (Sydney time) on Tuesday, 30 September 2025.
