Update on Scheme - Despatch of Scheme Booklet and Letter to NSX Shareholders

NSX Limited (ASX: NSX) (NSX) refers to its announcements made on 9 September 2025 in relation to the proposed Scheme of Arrangement under which 1001290557 Ontario Inc. (BidCo), a related body corporate of CNSX Markets Inc. (the market operator of the Canadian Securities Exchange) (CNSX) would acquire all of the shares on issue in NSX (that CNSX does not already own) (Scheme), and the orders made by the Federal Court of Australia that NSX convene and hold a meeting of NSX shareholders to consider and vote on the Scheme (Scheme Meeting) and approving the distribution to NSX shareholders of an explanatory statement providing information about the Scheme and Notice of Scheme Meeting (Scheme Booklet).

NSX is pleased to confirm that the Scheme Booklet has today been despatched to NSX shareholders in the manner described in its announcement of the registration of the Scheme Booklet with ASIC of 9 September 2025. A copy of the Scheme Booklet is also available on the NSX website at https://www.nsx.com.au/about/investor-relations/.

The attached letter has been sent today by post to NSX shareholders who have either not made an election as to the form of meeting documents they wish to receive or shareholders who have elected to receive only hardcopy meeting materials, in the manner described in NSX's announcement of 9 September 2025. NSX Limited - Scheme Meeting

On 9 September 2025, the Federal Court of Australia made orders that NSX Limited (**Company** or **NSX**) convene a meeting of its shareholders (**Scheme Meeting**) to consider and vote on the proposed Scheme of Arrangement under which 1001290557 Ontario Inc. (**BidCo**), a related body corporate of CNSX Markets Inc. (the operator of the Canadian Securities Exchange) (**CNSX**), would acquire all of the fully paid and partly paid ordinary shares on issue in NSX (that CNSX does not already own) (**Scheme**).

For the Scheme to proceed, it must be approved by NSX shareholders at the Scheme Meeting, and then by the Court. The Scheme is also subject to regulatory approvals and other conditions precedent.

Scheme Meeting

The Scheme Meeting, at which NSX shareholders can vote on the Scheme, will be held as a hybrid meeting at **12.00pm** on **Friday**, **10 October 2025** (Sydney time), both:

- in-person at Suite 20.02, Level 20, Australia Square, 264-278 George Street, Sydney NSW 2000; and
- virtually through an online meeting platform at https://meetings.lumiconnect.com/300-808-093-900.

NSX shareholders, and duly appointed proxies, attorneys and corporate representatives of NSX shareholders, are invited and encouraged to attend the Scheme Meeting.

Scheme Booklet

The Scheme Booklet issued by NSX in relation to the Scheme contains an explanatory statement providing information about the Scheme and includes the Notice of Scheme Meeting (**Scheme Booklet**).

The Scheme Booklet is available for viewing and downloading at https://www.nsx.com.au/about/investor-relations/and at https://boardroomlimited.com.au/meeting/nsxscheme2025.

The Scheme Booklet sets out important information regarding the Scheme including the reasons for the NSX directors' unanimous recommendation, the Independent Expert's Report, and the Notice of Scheme Meeting. Please read the Scheme Booklet carefully and in its entirety as it will assist you in making an informed decision on how to vote on the resolution to approve the Scheme.

Voting

Detailed information about how to attend the Scheme Meeting, how to vote at the Scheme Meeting and voting entitlements are set out in the Scheme Booklet.

Whilst live voting will be available on the day of the Scheme Meeting, proxy voting is now open and shareholders are **strongly recommended** to submit their votes by proxy in advance of the Scheme Meeting to ensure that their votes are received by the required time.

Proxy forms may be lodged with the NSX share registry as follows:

- online at https://www.votingonline.com.au/nsxscheme2025, where you will be asked to provide your postcode (within Australia) or country of residence (outside of Australia) and enter your Voting Access Code (VAC) as shown at the start of this letter and on the accompanying proxy form;

- by **posting** them using the reply-paid envelope provided (in the case of NSX shareholders who have elected to receive meeting materials in hardcopy);
- by posting them to Boardroom Pty Limited, GPO Box 3993, Sydney NSW 2001;
- by delivering them in person to Boardroom Pty Limited, Level 8, 210 George Street Sydney NSW 2000; or
- by faxing them to +61 2 9290 9655 (within and outside Australia).

To be effective, proxy votes must be received by **12.00pm on Wednesday**, **8 October 2025 (Sydney time)**, being 48 hours before the commencement of the Scheme Meeting.
