### SOL Share Scheme and BKW Share Scheme become legally effective

Further to the announcements by Washington H. Soul Pattinson and Company Limited ("**Soul Patts**" or "**SOL**") (ASX: SOL) and Brickworks Limited ("**Brickworks**" or "**BKW**") (ASX: BKW) on 12 September 2025, Soul Patts and Brickworks confirm that they have each lodged an office copy of the orders made by the Supreme Court of New South Wales ("**Court**") approving the SOL Share Scheme and the BKW Share Scheme respectively (together, the "**Share Schemes**"), with the Australian Securities and Investments Commission ("**ASIC**") pursuant to sub-section 411(10) of the *Corporations Act 2001* (Cth).<sup>1</sup>

Soul Patts and Brickworks are pleased to announce that the Share Schemes are now legally effective. The last day of trading of the Soul Patts and Brickworks shares on the ASX will be today, 15 September 2025,<sup>2</sup> following which Topco Shares will commence trading on a deferred settlement basis from Tuesday 16 September 2025<sup>3</sup> and on a normal settlement basis from Wednesday 24 September 2025.<sup>4</sup> The office copies of the respective Court orders lodged with ASIC are attached to this announcement at Annexure A and Annexure B respectively.

It is expected that on 22 September 2025, SOL Shareholders and BKW Shareholders who are on the share registers of Soul Patts and Brickworks (respectively) at 7:00pm (Sydney time) on 17 September 2025 (being the record date) will receive:

- for SOL Shareholders, 1 Topco Share for each Soul Patts share held on the record date; and
- for BKW Shareholders, 0.82 Topco Shares for each Brickworks share held on the record date.

Implementation of the Share Schemes is expected to occur on 23 September 2025.

The above timetable is indicative only and the stated times and dates are subject to change. Soul Patts and Brickworks will announce any changes to the ASX.

Black J makes orders in accordance with Short Minutes of Order initialled by him and placed in the file.

The Court orders that:

1 Pursuant to section 411(4)(b) of the Corporations Act 2001 (Cth) (Corporations Act), the scheme of arrangement between the plaintiff and holders of fully paid ordinary shares in the plaintiff (excluding Brickworks Limited and any wholly owned member of the Brickworks Group), the terms of which are in Annexure C of Exhibit 1 (Scheme), be approved.

2 Pursuant to section 411(12) of the Corporations Act, the plaintiff is exempt from compliance with section 411(11) of the Act in relation to the Scheme.

3 Pursuant to section 411(6) the Scheme be amended by replacing the definition of "Excluded SOL Shareholder" in clause 1.1 of the Scheme with the definition "Excluded SOL Shareholder means Brickworks Limited ACN 000 028 526 of 738-780 Wallgrove Road, Horsley Park, NSW 2175".

4 The plaintiff lodge with the Australian Securities and Investments Commission a copy of the approved Scheme at the time of lodging a copy of these orders.

5 That evidence in Proceedings No 2025/00239415 (in the matter of Brickworks Limited) be evidence in these proceedings, and vice versa.
