Opal HealthCare signs Master Services Agreement for Swift TV

- **Australia's Largest Aged Care Provider Orders Swift TV**
- **Swift TV to integrate into Opal HealthCare's Proprietary systems**
- **Minimum Revenue per site circa \$80,000 over 36-month term for Swift TV Engagement package based on 100 room Care Community**

Today, Swift announced Australia's largest aged care provider, Opal HealthCare signed a Master Services Agreement (MSA) with Swift for the provision of its new connected TV product, Swift TV, launching early 2026.

Opal HealthCare has a national portfolio of 142 Residential Care Communities serving over 13,000 residents across Australia. The company has grown significantly in recent years through mergers and acquisitions and continues to invest in new, state-of-the-art Care Communities.

Swift TV, the result of years of research and development, delivers a market-first, all-in-one in-room engagement and entertainment platform that simplifies the user experience, reduces installation time and cost, and strengthens Swift's competitive differentiation. Pre-orders opened in August 2025, with first installations scheduled for early 2026. Securing our first Swift TV customer ahead of launch confirms strong market demand and validates the product's potential for scalable adoption and accelerated revenue growth in FY26.

The Opal HealthCare MSA will initially cover 562 screens across four Opal HealthCare Care Communities, including their two newest developments, Epping Grand Care Community and Croydon Grove Care Community. The agreement sets the terms for the future roll out of Swift TV to additional Opal HealthCare Care Communities.

As part of the partnership, Swift and Opal HealthCare will integrate Swift TV with Opal HealthCare's proprietary management software bringing personalised content, menus

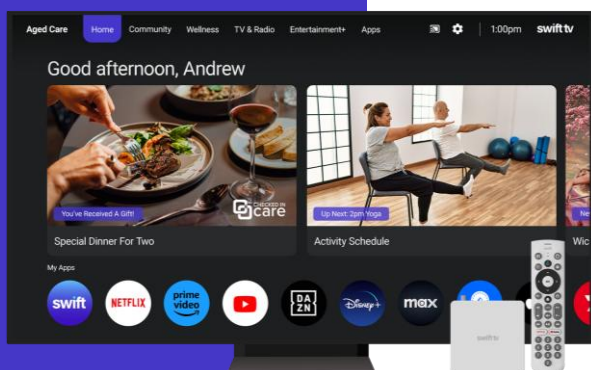
