## **Results of General Meeting**

BWE Drilling Limited (ASX: BWE) ("the Company") advises that a General Meeting of shareholders was held today at 76 Hasler Road, Osborne Park, Western Australia.

All resolutions that were put to shareholders at the meeting were passed by a poll.

This follows the Company's 21 August 2025 announcement, which outlined the rationale for delisting and confirmed BWE would remain listed for at least one month post-approval to allow shareholders to sell their shares.
