

# IP SURVEY COMMENCES - BLUE DEVIL IP SURVEY COMPLETION & SAMPLING – MT BOGGOLA

TechGen Metals Limited ("TechGen" or the "Company") is pleased to provide an update on activities at its highly prospective Blue Devil & Mt Boggola Projects in Western Australia. Blue Devil is located 40km northeast of Halls Creek. The Blue Devil Project presents an attractive, first-mover opportunity focused on the exploration of copper (Cu), gold (Au) and silver (Ag) within the Halls Creek Orogen. The project covers a significant landholding of 195km² across exploration licences E80/6047, E80/6084 and E80/6101. The Mt Boggola Project is located 60 km south of Paraburdoo and comprises Exploration Licences E08/2996, E08/3269 and E08/3830 covering a combined area of 449 km². The project is located in the Proterozoic-aged Ashburton and Edmund Basins. The Company is targeting shear zone hosted & intrusive related copper (Cu)-gold (Au)-antimony (Sb) mineralisation at the project.

#### **NEW STRATEGIC HIGHLIGHTS**

- New IP Geophysics survey has commenced at Blue Devil specifically targeting the recently discovered high-grade 52.3% Cu and 5.35g/t Au structural zones.
- Rock chip sampling (18 samples) of copper gossans close to the MB1 & MB2 IP targets has recently completed at Mt Boggola with samples at the laboratory.
- Mt Boggola stage 2 IP survey has now been completed with data modelling & processing underway. This IP survey was to the west of stage 1 and has covered previous Newcrest Mining drill holes PB14 & PB15 which both had primary copper sulphide (chalcopyrite) logged towards the bottom of both holes.
- Heritage Survey at MB1 & MB2 and any additional targets identified in the new IP survey rescheduled for the 21<sup>st</sup> October.




Figure 1: Stage 1 completed IP (magenta) and stage 2 IP (green), chargeability targets and previous exploration.

Previously announced by the Company, Northern Star Resources Limited held parts of the current Mt Boggola Project area between 2015 – 2018 and undertook detailed soil sampling over an area that had malachite bearing gossans and an underlying gravity feature they interpreted might represent an intrusive body. The soil anomaly Northern Star outlined has coincident copper and arsenic oriented in a northwest – southeast direction, gold anomalism is smaller in extent but in the same orientation whilst the lead soil anomaly is only partially coincident.

The soil anomaly is possibly related to a large-scale northeast-southwest striking fault structure that runs through the area. The Northern Star Soil Anomaly has peak values of 1,070ppm Cu, 60ppb Au, 240ppm As and 593ppm Pb. High grade rock chip results returned from the soil anomaly area include gold (48.8g/t, 34.5g/t, 7.73g/t, 4.82g/t & 3.47g/t), copper (27.8%, 20.3% & 16.75%), antimony (3.92%, 3.51% & 2.27%) and lead (3.72%, 1.38% & 1.04%; TG1 ASX announcement 26/11/2024).




Figure 2: Target MB1 & MB2 East-West IP high chargeability 3D model showing the resistivity (aqua) component.

The identified chargeability targets, MB1 & MB2, have not previously been drill tested with five drill holes completed by Newcrest Mining in 1991 all stopping short of the high chargeability zone at MB1 (Figures 1 & 2).




Figure 3: Blue Devil Target

At the Blue Devil Project an IP geophysical survey has commenced to cover a recently identified zone of high-grade copper gossans (Photo 4) and iron-quartz-gold zones. These two parallel zones are approximately 80m apart and were identified during August 2025. Twelve rock chip samples were collected along an east-west quartz structural corridor over approximately 2km with copper samples of 52.3% Cu, 22.6% Cu & 21% Cu and 5.35 g/t Au & 1.84g/t Au (TG1 ASX announcement 28/08/2025). Given the style of mineralisation and exceptional grades an IP survey is being undertaken across the area to hopefully identify additional drill targets to add to the already identified 2.75km long EM conductor and intrusion targets (Figure 3).


