The SPP provided eligible shareholders who held shares at 7:00pm (AEST) on Tuesday, 19 August 2025 (Record Date) the opportunity to apply for up to \$30,000 worth of new fully paid ordinary shares at the same issue price (\$0.19 per share) as the recently completed placement (refer to ASX Announcement dated 20 August 2025).

The Company was targeting to raise \$5 million (before costs) under the SPP and valid applications totalling \$9,831,293 were received. The Company has elected to accept the applications above the targeted raise amount, increasing the total funds secured from the recent placement and SPP to \$89.8 million before costs.

Arafura's Managing Director and CEO, Darryl Cuzzubbo said "The strong support received from our shareholders, exceeding our target for this capital raising, is a powerful endorsement of our future.

We have a clear path to becoming a material supplier of rare earths globally and this raising demonstrates continued momentum towards securing the remaining capital in a timely and attractive manner.

I extend my thanks to all our existing shareholders for their continued support. Together, we are building a company that will play a vital role in diversifying the global rare earths supply chain and create multi-generational value."

The shares issued under the SPP will rank equally with the Company's existing fully paid ordinary shares on issue.

A total of 51,743,890 SPP Shares have been issued today and an ASX Appendix 2A will follow this announcement.
