#### Item 1 - Statement and Reports

To receive and consider the Annual Report, the Financial Report and the reports and statements of the Directors and of the Auditor for the year ended 30 June 2025.

Note: There is no requirement for Shareholders to approve these reports.

#### Item 2 - Ordinary Business

#### 1. Adoption of Remuneration Report

To consider and, if thought fit, to pass the following Resolution as a **non-binding ordinary resolution**:

"To adopt the Remuneration Report set out in the Directors' Report for the year ended 30 June 2025."

Please note that the vote on Resolution 1 is advisory only and does not bind the Directors or the Company.

#### Voting exclusion statement on Resolution 1:

A vote on Resolution 1 must not be cast (in any capacity) by, or on behalf of, the following persons:

- a) a member of the Key Management Personnel (KMP) whose remuneration details are included in the 2025 Remuneration Report; or
- a closely related party of such a KMP (including close family members and companies the KMP controls).

However, a person described above may cast a vote on Resolution 1 as a proxy if the vote is not cast on behalf of a person described above and either:

- a) the proxy appointment is in writing that specifies the way the proxy is to vote (e.g. for, against, abstain) on the resolution; or
- b) the vote is cast by the chair of the Meeting and the appointment of the chair as proxy:
  - i. does not specify the way the proxy is to vote on the resolution; and
  - ii. expressly authorises the chair to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the KMP.

In accordance with section 250BD of the Corporations Act 2001 (Cth), a vote must not be cast on Resolution 1 as a proxy by a member of the KMP at the date of the AGM, or a closely related party of those persons, unless it is cast as proxy for a person entitled to vote in accordance with their directions. This restriction on voting undirected proxies does not apply to the Chair of the Meeting where the proxy appointment expressly authorises the Chair of the Meeting to exercise undirected proxies even if the resolution is connected, directly or indirectly, with the remuneration of the KMP.

"Key management personnel" and "closely related party" have the same meaning as set out in the Corporations Act 2001 (Cth).

#### 2. Re-election of Andrew Burns as a Non-Executive Director

To consider and, if thought fit, to pass the following Resolution as an **ordinary resolution** of the Company:

"That Mr Andrew Burns, who was appointed to the Board in accordance with Clause 13.1 of the Company's Constitution and ASX Listing Rule 14.5 and being eligible for reelection, is elected as a Director of the Company."

#### 3. Approval of 10% Placement Facility

To consider and, if thought fit, to pass the following Resolution as a **special resolution** of the Company:

"That, pursuant to and in accordance with ASX Listing Rule 7.1A and for all other purposes, Shareholders approve the issue of equity securities up to 10% of the issued capital of the Company (at the time of the issue) calculated in accordance with the formula prescribed in Listing Rule 7.1A.2 and on the terms and conditions described in the Explanatory Statement which forms part of the Notice of Meeting."

  - ii. the holder votes on Resolution 3 in accordance with directions given by the beneficiary to the holder to vote in that way.

#### 4. Approval of Issue of Options to Harry Konstantinou

To consider and, if thought fit, to pass the following Resolution as an **ordinary resolution** of the Company:

"That approval be given:

(a) for the purpose of Listing Rule 10.14 and all other purposes, for the Company to grant 549,044 zero-priced options to Managing Director Harry Konstantinou or his nominee(s); and

(b) for the purpose of section 200E of the Corporations Act, to the giving of a benefit to Managing Director Harry Konstantinou, in connection with any accelerated vesting of those zero-priced options on cessation of Mr Konstantinou's employment with the Company or a related body corporate of the Company,

in each case under the Company's Long Term Incentive Plan on the terms and conditions described in the Explanatory Statement."

#### Voting exclusion statement on Resolution 4:

In accordance with ASX Listing Rule 14.11 and section 200E(2A) of the Corporations Act, the Company will disregard any votes cast in favour of Resolution 4 by or on behalf of:

- a) Harry Konstantinou; or
- b) an associate of Mr Konstantinou

Additionally, in accordance with ASX Listing Rule 14.11, the Company will also disregard any votes cast in favour of Resolution 4 by or on behalf of a person referred to in ASX Listing Rule 10.14.1, 10.14.2 or 10.14.3 who is eligible to participate in the employee incentive scheme in question.

#### **Explanatory Statement**

#### 1. Background

#### 1.1 Introduction

This Explanatory Statement has been prepared for the information of Shareholders in relation to the business to be conducted at the Company's Annual General Meeting (**Meeting**) to be held on Thursday 20 November 2025 at 9:00am (AEDT).

The purpose of this Explanatory Statement is to provide Shareholders with all information known to the Company which is material to a decision on how to vote on the Resolutions set out in the accompanying Notice. It explains the Resolutions and identifies the Board's reasons for putting them to Shareholders.

Subject to the abstentions noted below, the Directors unanimously recommend Shareholders vote in favour of all Resolutions. The Chair of the Meeting intends to vote all available undirected proxies in favour of each resolution.

Resolution 1, relating to the Remuneration Report, is advisory and does not bind the Directors or the Company.

Resolutions 2 & 4 are ordinary resolutions, which require a simple majority of votes cast by Shareholders present and entitled to vote on the resolution.

Resolutions 3 & 5 are to be voted on as special resolutions. For a special resolution to be passed, at least 75% of the votes cast by Shareholders present and entitled to vote on the resolution must be in favour of the resolution.

#### 1.2 Action to be taken by Shareholders

Shareholders should read this Explanatory Statement carefully before deciding how to vote on the Resolutions set out in the Notice.

All Shareholders are invited and encouraged to attend the Meeting (either in person or online). If Shareholders are unable to attend the Meeting, the attached Proxy Form should be completed, signed and returned to the Company in accordance with the instructions contained in the Proxy Form and the Notice. Lodgement of a Proxy Form will not preclude a Shareholder from attending and voting at the Meeting (either in person or online), but the person appointed as the proxy must not exercise the rights conferred by the Proxy Form, and attendance at the Meeting will make any proxy vote invalid.

#### 2. Statement and Reports

#### 2.1 Consideration of Reports

The first item of business is to receive and consider the Financial Report, the Directors' Report, and the Independent Auditor's Report of the Company for the financial year ended 30 June 2025.

All Shareholders can view the Company's Annual Report which contains the Financial Report, the Directors' Report and the Independent Auditor's Report of the Company for the year ended 30 June 2025 on the Company's website at <a href="https://investors.vivaleisure.com.au/investor-centre/?page=annual-reports">https://investors.vivaleisure.com.au/investor-centre/?page=annual-reports</a>.

Shareholders are not required to vote on this item.

#### 2.2 Questions and Comments

Following consideration of the Reports, the Chair of the Meeting will give Shareholders a reasonable opportunity to ask questions about or make comments on the business of the Meeting, the management of the Company or about the Company generally.

The Company's external Auditor will attend the Meeting and there will be a reasonable opportunity for Shareholders to ask the Auditor questions relevant to:

- a. the conduct of the audit;
- b. the preparation and content of the Independent Auditor's Report;
- c. the accounting policies adopted by the Company in relation to the preparation of the financial statements; and
- d. the independence of the Auditor in relation to the conduct of the audit.

The Chair will also give the Auditor a reasonable opportunity to answer written questions submitted by Shareholders that are relevant to the above matters.

#### 3. Resolutions

#### 3.1 Resolution 1 – Adoption of Remuneration Report

The Remuneration Report for the year ended 30 June 2025 outlines the remuneration arrangements of the Company in accordance with the requirements of the Corporations Act and its regulations. The report details the remuneration arrangements for Key Management Personnel which includes Non-Executive Directors, the Managing Director and key senior executives. The report is set out in the 2025 Annual Report which is also available on the Company's website at <a href="https://investors.vivaleisure.com.au/investor-centre/?page=annual-reports">https://investors.vivaleisure.com.au/investor-centre/?page=annual-reports</a>.

The Board is committed to ensuring that the remuneration structure for Key Management Personnel is closely aligned to the strategy and business objectives of the Company, with a focus on driving a performance culture and delivering results that are acceptable to Shareholders. It is the Board's objective to deliver a Remuneration Report which explains the way in which financial rewards for Key Management Personnel drive the Company's short-term and long-term performance.

Shareholders will be given a reasonable opportunity at the Meeting to raise questions and make comments on the Remuneration Report.

The vote on the adoption of the Remuneration Report is advisory only and does not bind the Directors or the Company. However, the Directors will take the outcome of the vote into consideration when reviewing the remuneration practices and policies of the Company.

The Company encourages all Shareholders to cast their vote on Resolution 1.

In summary, the Remuneration Report:

- (a) explains the Board's policies in relation to the nature and level of remuneration paid to Directors and Key Management Personnel of the Company;
- (b) discusses the link between the Board's policies and the Company's performance; and
- (c) sets out remuneration details for each Director and for each member of the Company's senior executive management team.

A voting exclusion statement applies to this resolution, as set out in this Notice of Meeting.

#### Recommendation

Noting that each Director has a personal interest in their own remuneration from the Company, as described in the Remuneration Report, the Board unanimously recommends that Shareholders vote in favour of Resolution 1.

#### 3.2 Resolution 2 – Re-Election of Robert (Andrew) Burns as Non-Executive Director

Resolution 2 is an ordinary resolution which seeks approval for the re-election of Robert (Andrew) Burns as a Non-Executive Director of the Company. Mr Burns was appointed as a Non-Executive Director of the Company on 20 April 2022 and was re-elected at the AGM on 24 October 2022. Pursuant to clause 13.3 of the Company Constitution and ASX Listing Rule 14.5, Mr Burns is required to retire as Non-Executive Director and stand for re-election at this meeting, being the third annual general meeting since his election.

#### Details of the experience and qualifications of Mr Burns are as follows:

Andrew has over 25 years' experience in senior finance roles in the technology, financial services and healthcare sectors with a strong technical background in accounting and financial management, risk management and business process improvement.

Over the last 10 years Andrew has held the position the Chief Financial Officer through three IPO's, The Citadel Group Limited (ASX CGL) in 2014, Openpay Limited (ASX:OPY) 2019 and RAS Technology Holding Limited (ASX:RTH) 2021. As CFO and Company Secretary (CGL) Andrew has extensive management experience in corporate governance, financial compliance, mergers and acquisitions, investor relations and capital raisings.

Andrew holds a Bachelor of Commerce from the University of Canberra, an Executive Master of Business Administration from the Australian Graduate School of Management UNSW, he is a Chartered Accountant and a member of the Australian Institute of Company Directors.

The Board has considered whether Mr Burns has any interest, position or relationship that may interfere with his independence as a Director, having regard to the relevant factors as set out in the ASX Corporate Governance Principles and Recommendations (4<sup>th</sup> edition). The Board considers that Mr Burns (if elected), will continue to be an independent Director.

#### Recommendation

The Directors (excluding Mr Burns due to his personal interest) unanimously recommend Shareholders vote in favour of this Resolution 2.

#### 3.3 Resolution 3 - Approval of 10% Placement Facility

#### **General**

ASX Listing Rule 7.1 generally limits the amount of equity securities that a listed entity can issue without the approval of its Shareholders over any 12-month period to 15% of the fully paid ordinary securities it had on issue at the start of that period.

However, under ASX Listing Rule 7.1A certain listed companies may seek Shareholder approval by special resolution to issue equity securities equivalent to an additional 10% of the number of ordinary securities on issue by way of placement over a 12-month period (10% Placement Facility). This is in addition to the existing 15% placement capacity permitted by ASX Listing Rule 7.1.

A company is eligible to seek Shareholder approval for this additional placement capacity under ASX Listing Rule 7.1A if it satisfies both of the following criteria at the date of the meeting at which that approval is sought:

- a. it has a market capitalisation of \$300 million or less; and
- it is not included in the S&P/ASX 300 Index.

The Company currently satisfies both the above criteria, and it is anticipated that it will satisfy both these criteria at the date of the AGM. If on the date of the AGM, the Company no longer meets this eligibility criteria, this Resolution 3 will be withdrawn.

The Company is now seeking Shareholder approval by way of a special resolution to have the ability to issue Equity Securities under the 10% Placement Facility. The exact number of Equity Securities to be issued under the 10% Placement Facility will be determined in accordance with the formula prescribed in Listing Rule 7.1A.2 (refer to below).

The Company may use the funds raised from the issue of Equity Securities under the 10% Placement Facility for such things including but not limited to means to generally expand the Company's business.

Approval of Resolution 3 does not oblige the Company to conduct a placement or use the 10% Placement Facility. The approval would provide the Company with additional flexibility and an ability to move quickly if an opportunity arises which requires additional capital.

#### **Description of ASX Listing Rule 7.1A**

#### Shareholder approval

The ability to issue Equity Securities under the 10% Placement Facility is subject to Shareholder approval by way of a special resolution at an annual general meeting.

#### Equity Securities

Any Equity Securities issued under the 10% Placement Facility must be in the same

class as an existing quoted class of Equity Securities of the Company. The Company, as at the date of the Notice, has on issue both quoted and unquoted classes of Equity Securities, being Shares and unlisted options.

#### Formula for calculating 10% Placement Facility

Listing Rule 7.1A.2 provides that eligible entities which have obtained Shareholder approval under Listing Rule 7.1A at an annual general meeting may issue or agree to issue, during the 12-month period after the date of the annual general meeting, a number of Equity Securities calculated in accordance with the following formula:

#### Where:

**A** is the number of fully paid ordinary shares on issue 12-months before the date of issue or agreement:

- (A) plus the number of fully paid shares issued in the 12-months under an exception in Listing Rule 7.2 other than exception 9, 16 or 17;
- (B) plus the number of fully paid ordinary securities issued in the 12-months on the conversion of convertible securities within rule 7.2 exception 9 where:
  - the convertible securities were issued or agreed to be issued before the commencement of the relevant period; or
  - the issue of, or agreement to issue, the convertible securities was approved, or taken under these rules to have been approved, under Listing Rule 7.1 or Listing Rule 7.4;
- (C) plus the number of fully paid ordinary securities issued in the 12-months under an agreement to issue securities within rule 7.2 exception 16 where:
  - the agreement was entered prior to 12 months ago; or
  - the agreement or issue was approved, or taken under these rules to have been approved, under Listing Rule 7.1 or Listing Rule 7.4;
- (D) plus the number of any other fully paid ordinary securities issued in the 12-months with approval under Listing Rule 7.1 or Listing Rule 7.4;
- (E) plus the number of partly paid shares that became fully paid in the 12-months;
- (F) less the number of fully paid shares cancelled in the 12-months.

Note that A has the same meaning in Listing Rule 7.1 when calculating an entity's 15% placement capacity.

**D** is 10%.

**E** is the number of Equity Securities issued or agreed to be issued under Listing Rule 7.1A.2 in the 12 months before the date of the issue or agreement that have not been subsequently approved by Shareholders under Listing Rule 7.4.

#### Listing Rule 7.1 and Listing Rule 7.1A

The ability of an entity to issue Equity Securities under Listing Rule 7.1A is in addition to the entity's 15% placement capacity under Listing Rule 7.1.

At the date of this Notice, the Company has on issue 98,564,369 Ordinary Shares and has the capacity to issue 14,781,955 Equity Securities under Listing Rule 7.1 without Shareholder approval. Further as at the date of this Notice, following Shareholder approval being obtained under Resolution 3, the Company will have capacity to issue a further 9,854,637 Equity Securities under Listing Rule 7.1A.

However, the actual number of Equity Securities that the Company will have capacity to issue under Listing Rule 7.1A will be calculated at the date of issue of the Equity Securities in accordance with the formula prescribed in Listing Rule 7.1A.2 (refer to above).

#### Minimum Issue Price

The issue price of Equity Securities issued under Listing Rule 7.1A must be not less than 75% of the VWAP of Equity Securities in the same class calculated over the 15 Trading Days immediately before:

- (a) the date on which the price at which the Equity Securities are to be issued is agreed; or
- (b) if the Equity Securities are not issued within 10 Trading Days of the date in paragraph (a) above, the date on which the Equity Securities are issued.

#### 10% Placement Period

Shareholder approval of the 10% Placement Facility under Listing Rule 7.1A is valid from the date of the annual general meeting at which the approval is obtained and expires on the earlier to occur of:

- (a) the date that is 12-months after the date of the annual general meeting at which the approval is obtained; or
- (b) the date of the approval by Shareholders of a transaction under Listing Rules 11.1.2 (a significant change to the nature or scale of activities) or 11.2 (disposal of main undertaking), or such longer period if allowed by ASX; or
- (c) the time and date of the Company's next AGM if it is held prior to 20 November 2026.

#### (10% Placement Period)

#### Listing Rule 7.1A

The effect of Resolution 3 will be to allow the Directors to issue the Equity Securities under Listing Rule 7.1A during the 10% Placement Period without using the Company's 15% placement capacity under Listing Rule 7.1.

If Shareholders approve Resolution 3, the effect will be to allow the Company to issue equity securities under ASX Listing Rule 7.1A up to 15% capacity for ASX Listing Rules 7.1 and an additional 10% capacity for ASX Listing Rule 7.1A without further Shareholder approval.

If Shareholders do not approve Resolution 3, the Company will not be able to access the additional 10% capacity to issue equity securities without Shareholder approval under ASX Listing Rule 7.1A and will remain subject to the 15% capacity limit on issuing equity securities without Shareholder approval under ASX Listing Rule 7.1.

#### Specific information required by Listing Rule 7.3A

Pursuant to and in accordance with Listing Rule 7.3A, information is provided in relation to the approval of the 10% Placement Facility as follows:

- (a) The Company will only issue and allot the Equity Securities during the 10% Placement Period, that is, within 12-months of the date of the AGM (ie. By 20 November 2026). The approval under Resolution 3 for the issue of the Equity Securities will cease to be valid the earlier of either of the following events occurring:
  - (i) The time and date of the Company's next AGM if it is held prior to 20 November 2026; or
  - (ii) In the events that Shareholders approve a transaction under Listing Rule 11.1.2 (a significant change to the nature or scale of activities or Listing Rule 11.2 (disposal of main undertaking).
- (b) The Equity Securities must be issued for cash consideration and will be issued at an issue price of not less than 75% of the VWAP for the Company's Equity Securities over the 15 Trading Days immediately before:
  - (i) the date on which the price at which the Equity Securities are to be issued is agreed; or
  - (ii) if the Equity Securities are not issued within 10 Trading Days of the date in paragraph (i) above, the date on which the Equity Securities are issued.
- (c) The Company may seek to issue the Equity Securities for the following purposes including but not limited to using the funds raised for the growth of its existing business, acquisition of new or existing businesses including costs associated with such acquisitions, assets and investments and also for other means to generally expand the Company's business and general working capital.
  - The Company will comply with the disclosure obligations under Listing Rules 7.1A(4) and 3.10.5A upon issue of any Equity Securities.
- (d) If Resolution 3 is approved by Shareholders and the Company issues Equity Securities under the 10% Placement Facility, the existing Shareholders' voting power in the Company will be diluted as shown in the below table. There is a risk that:
  - (i) the market price for the Company's Equity Securities may be significantly lower on the date of the issue of the Equity Securities than on the date of the Meeting; and
  - (ii) the Equity Securities may be issued at a price that is at a discount to the market price for the Company's Equity Securities on the issue date,

which may have an effect on the amount of funds raised by the issue of the equity securities.

The below table shows the dilution of existing Shareholders on the basis of the closing price of the Company's Shares of \$1.775 each on 10 October 2025 and the current number of ordinary securities for variable "A" calculated in accordance with the formula in Listing Rule 7.1A.2 as at the date of this Notice.

The table also shows:

- (i) two examples where variable "A" has increased, by 50% and 100%. Variable "A" is based on the number of ordinary securities the Company has on issue. The number of ordinary securities on issue may increase as a result of issues of ordinary securities that do not require Shareholder approval (for example, a pro rata entitlements issue or scrip issued under a takeover offer) or future specific placements under Listing Rule 7.1 that are approved at a future Shareholders' meeting; and
- (ii) two examples of where the issue price of ordinary securities has decreased by 50% and increased by 100% as against the current market price.

a case-by-case basis having regard to various factors including but not limited to the following:

- the methods of raising funds that are available to the Company, including but not limited to, rights issue or other issue in which existing security holders can participate;
- (ii) the effect of the issue of the Equity Securities on the control of the Company;
- (iii) the financial situation and solvency of the Company; and
- (iv) advice from corporate, financial and broking advisers (if applicable).

The allottees under the 10% Placement Facility have not been determined as at the date of this Notice but may include existing substantial Shareholders and/or new Shareholders who are not related parties or associates of a related party of the Company.

Further, if the Company is successful in acquiring new businesses, assets or investments, it is likely that the allottees under the 10% Placement Facility will be the vendors of these assets or investments.

- (f) The Company previously obtained Shareholder approval under ASX Listing Rule 7.1A at its 2024 Annual General Meeting held on 24 October 2024.
- (g) The Company has not previously issued or agreed to issue equity securities under ASX Listing Rule 7.1A.2 in the 12-months preceding this AGM.
- (h) A voting exclusion statement is included in the Notice.

Resolution 3 is a special resolution. For a special resolution to be passed, at least 75% of the votes cast by Shareholders present and entitled to vote on the resolution must be in favour of the resolution.

#### **Directors' recommendation**

The Board unanimously recommends that Shareholders vote in favour of Resolution 3.

#### 3.4 Resolution 4 - Approval of Issue of Options to Harry Konstantinou under LTI Plan

Resolution 4 seeks approval from Shareholders for the issue of 549,044 unlisted "zero-priced" Options to Managing Director Harry Konstantinou, or his nominee, and the subsequent issue of Shares upon the exercise of the Options.

Resolution 4 also seeks approval from Shareholders for the purposes of section 200E of the Corporations Act if those Options are accelerated for vesting upon Harry ceasing to be employed by the Company (or a related body corporate).

Neither Harry nor the Company has any intention for Harry to cease employment with the Company, and this Resolution for section 200E purposes is purely to ensure the Company is able to honour the terms of Harry's Options under the LTI Plan.

As CEO and Managing Director, Harry is entitled to participate in the Company's Long-Term Incentive Plan (LTI Plan). Under the LTI Plan, Directors, management and key employees identified by the Board can be offered participation in the form of Options including Options with a zero-exercise price, and/or performance rights. Those grants are designed to assist in the reward, retention and motivation of the Company's

management and key employees. In the 2025 financial year, Harry was granted 307,106 Zero Priced Options under the terms of the LTI Plan which was supported by the majority vote of Shareholders.

The Board has determined that it is appropriate to grant zero-priced Options to Harry as part of his executive remuneration for FY 2026 being 549,044 Zero Priced Options, subject to achievement of performance hurdles and employment continuity requirements determined by the Board. Options to be issued will vest on satisfaction of the achievement of two separate hurdles. 274,522 Options for part "A" hurdles and 274,522 Options for part "B" hurdles. That is a total of 549,044 Options. The grant of these Options is expected to occur immediately following Shareholder approval, but in any event no later than 12 months after approval.

A copy of the LTI Plan is available upon request from the Company. However, a summary of the key terms of the Options proposed to be issued to Harry under the LTI Plan are provided below:

- each Option will be issued for nil consideration and has a zero exercise price;
- each option has no voting rights and is not entitled to dividends;
- each Option represents a right to an ordinary share in the Company, subject to vesting conditions being met;
- Harry must remain employed by the Company's subsidiary Viva Leisure People
  Pty Ltd (or one of its related entities) as at 31 August 2028 in order for those
  Options to vest and become exercisable without further Board approval;
- the exercise of the Options is also subject to the satisfaction of certain performance hurdles which are determined by the Board. The table below describes the performance hurdles and vesting condition that the Board has determined will apply to the Options proposed to be issued to Harry:

- in the event that Harry ceases employment, then the treatment of his Options will depend on whether he is considered to be a "good leaver" or a "bad leaver" under the LTI Plan rules;
- if a change of control event occurs, the Options may be subject to accelerated vesting in accordance with the LTI Plan rules and subject to the discretion of the Board; and
- the Board has absolute discretion in determining all matters in respect of retesting, hedging of unvested Options, change of control and malus and clawback.

#### **Listing Rules**

Under Listing Rule 10.14, the acquisition of securities by a Director under an employee incentive scheme (such as the LTI Plan) requires Shareholder approval.

Accordingly, the Company is seeking approval for the issue of the 549,044 zero-priced Options to Harry for the purposes of Listing Rule 10.14.

In accordance with the Listing Rules, Shareholders are being asked under Resolution 4 to approve the grant of the Options to Harry and, to the extent those Options are exercised, the issue of Ordinary Shares.

Exception 14 in Listing Rule 7.2 provides that Listing Rule 7.1 does not apply where Shareholder approval for an issue of securities is obtained under Listing Rule 10.14.

This means that, if Shareholder approval is obtained for Resolution 4, the issue of the Options and the issue of underlying Shares will not deplete the Company's 15% placement capacity under Listing Rule 7.1.

If Shareholders do not approve Resolution 4, the proposed issue of Options to Harry will not proceed. However, to ensure the Company can attract and retain the right talent and align the senior management interests with those of Shareholders, the Board considers it is important for the Company to offer incentives to its directors and executives that are in line with market practice. The Board would need to consider alternative remuneration arrangements.

#### **Corporations Act**

#### Chapter 2E

Chapter 2E of the Corporations Act regulates the provision of financial benefits to related parties of a public company. Section 208 of the Corporations Act prohibits a public company giving a financial benefit to a related party unless one of a number of exceptions applies or Shareholder approval is obtained. For the purposes of Chapter 2E, Harry as Managing Director is a related party of the Company, by virtue of sections 228(2) of the Corporations Act.

The Board is satisfied that the "reasonable remuneration" exception in relation to Chapter 2E of the Corporations Act applies to the proposed issue of Options to Harry under the LTI Plan.

#### Chapter 2D

The Company seeks Shareholder approval pursuant to section 200E of the Corporations Act for accelerated vesting of unvested Options granted to Harry pursuant to this Resolution 4 in the event that Harry ceases to be employed by the Company (or a related body corporate) in limited circumstances. Circumstances where Harry's unvested Options may be accelerated for vesting include upon cessation of employment as a "good leaver" under the LTI Plan rules, as well as cessation of employment due to a change of control event occurring. Unless expressly set out in the LTI Plan rules, the extent of acceleration, if any, is subject to the discretion of the Board exercised in accordance with the LTI Plan rules.

Neither Harry nor the Company has any intention for Harry to cease employment with the Company, and this Resolution for section 200E purposes is purely to ensure the Company is able to honour the terms of Harry's Options under the LTI Plan.

Under section 200B of the Corporations Act, a company may only give a person a "benefit" in connection with the person ceasing to hold a managerial or executive office in the company (or a related body corporate of the Company) (**Termination Benefit**) if it is approved by Shareholders under section 200E of the Corporations Act (or if an exemption applies). The term "benefit" is likely to include the accelerated vesting of Options in the limited circumstances outlined above where Harry ceases to be employed by the Company (or a related body corporate of the Company). The accelerated vesting of Harry's Options, in those limited circumstances, is likely to amount to the giving of a Termination Benefit requiring Shareholder approval. Therefore, Shareholder approval is sought for these purposes.

For the purpose of seeking Shareholder approval under section 200E of the Corporations Act, the following is disclosed:

- The maximum number of Options (for which approval is sought) that may accelerate for vesting upon cessation of Harry's employment is 549,044 being equal to the number of Options for which approval under Listing Rule 10.14 is being sought;
- The value of the "benefit" provided to Harry upon acceleration of unvested Options cannot be calculated in advance. This is because various matters will, or are likely

to affect that value including:

- o the number of unvested Options that are accelerated for vesting;
- the expected remaining term to expiration of the Options, at time of acceleration;
- o the price of the Company's shares as at time of acceleration;
- the expected volatility of the price of the Company's shares for the expected remaining term of the Options;
- the expected dividends (if any) on the Company's shares for the expected remaining term of the Options; and
- the risk free interest rate for the expected remaining term of the Options.
- The Company will calculate the value of the benefit at the relevant time based on the above factors and using the appropriate options pricing model to value the accelerated Options.
- A voting exclusion statement for the purposes of section 200E(2A) is included in this Notice.

#### Directors' recommendation

The Board (except Harry due to his personal interest) considers that the award of securities to Harry Konstantinou is an appropriate incentive and in the best interests of the Company and therefore recommends that Shareholders vote in favour of Resolution 4.

#### 3.5 Resolution 5 – Section 260B Shareholder Approval

#### Background

Viva Leisure Operations Pty Ltd ACN 609 536 665 (**Viva Leisure Operations**) has acquired all of the issued share capital of each of:

- (a) World Gym Coomera Pty Ltd ACN 610 919 723;
- (b) World Gym Stafford Pty Ltd ACN 623 827 690; and
- (c) World Gym Underwood Pty Ltd ACN 632 537 921,

(each a World Gym Company).

Viva Leisure Operations obtained part of the funding for the purchase price for each of these acquisitions under the Viva Leisure Group's financing arrangements in place with, among others, Commonwealth Bank of Australia ABN 48 123 123 124 (**CBA**).

It is a requirement under the financing arrangements in place with CBA that the World Gym Companies become guarantors of the obligations of the Company, Viva Leisure Operations and the other subsidiaries of the Company which are obligors under those financing arrangements, and provide all assets security to secure the obligations under the CBA financing arrangements.

#### Restrictions on companies providing financial assistance

Under section 260(A)(1) of the Corporations Act, a company may financially assist a person to acquire shares (or units of shares) in the company or a holding company of the company only if:

- (a) giving the financial assistance does not materially prejudice:
  - (i) the interests of the company or its shareholders; or
  - (ii) the company's ability to pay its creditors; or
- (b) the assistance is approved by shareholders under section 260B of the Corporations Act; or
- (c) the assistance is exempted under section 260C of the Corporations Act.

#### Particulars of proposed financial assistance

The Company and Viva Leisure Operations are party to a Syndicated Facility Agreement dated 20 November 2024 (**Facility Agreement**) with, among others, CBA and CBA Corporate Services (NSW) Pty Limited ACN 072 765 434 (**Security Trustee**). Under the Facility Agreement, the total commitments are \$165,000,000. However, it is expected that, subject to the approval of CBA, the commitments may increase over time.

Under the Facility Agreement, the Company must ensure that the aggregate EBITDA and total assets of the guarantors under the Facility Agreement represent at least 95% of the EBITDA and total assets of the Viva Leisure Group (respectively). To satisfy this requirement, the World Gym Companies must become guarantors under the Facility Agreement.

It is proposed that, following the approvals under section 260B of the Corporations Act, each World Gym Company enter into the following documents (**Documents**):

- (a) an accession letter under which, among other things, the World Gym Company agrees to become a guarantor under the Facility Agreement and be bound by the terms of the Facility Agreement applicable to it as a guarantor;
- (b) an accession deed under which, among other things, the World Gym Company assumes the obligations and acquires the rights of an obligor under the Security Trust Deed dated 20 November 2024 (**Security Trust Deed**);
- (c) a general security deed under which, among other things, the World Gym Company grants a security interest over all of its assets in favour of the Security Trustee; and
- (d) certain other documents or transactions that are related to or contemplated by the documents described in paragraphs (a) to (c) above and/or the Facility Agreement and Security Trust Deed.

The entry into the Documents would constitute financial assistance within the meaning of section 260A of the Corporations Act in so far as it assists Viva Leisure Operations to acquire the issued share capital of each World Gym Company.

In addition, a borrower under the Facility Agreement may arrange refinancing and additional financing facilities (including working capital facilities) of an amount to be determined in the future from time to time. In order to secure and regulate the obligations of that borrower, each World Gym Company and any subsidiary of the World Gym Company may, from time to time:

- (a) execute, or accede to, a new facilities agreement as an obligor on terms acceptable to the World Gym Company at the relevant time;
- (b) give one or more of a guarantee, indemnity or security interest over its assets (whether by way of mortgage, fixed or floating (or both) charge or otherwise) to secure each obligor's obligations under any new facilities agreement or any related document; and
- (c) execute, or accede to, any document in connection with or ancillary to, any new facilities agreement, or guarantee, indemnity or security interest given in connection with any new facilities agreement, and any related document,

(**Refinancing**). The Refinancing may also amount to financial assistance under section 260A of the Corporations Act.

If the Resolution is not passed and the security from each World Gym Company is not provided, CBA is entitled to terminate the facilities (**Facilities**) under the Facility Agreement and demand immediate repayment of the Facilities.

#### Effect of the financial assistance

The entry into the Documents and any security in connection with the Facility Agreement may impact on each World Gym Company's ability to borrow money in the future. This is because a lender may be deterred by the existence of the Documents from making finance facilities available to the World Gym Company.

However, the Company, Viva Leisure Operations and each World Gym Entity agreed to the arrangements contemplated in the Documents because they believe them to be in the best interests of each World Gym Entity. The Facilities available under the Facility Agreement are also available to be applied for purposes related to the whole of the Viva Leisure Group, including each World Gym Company. The Company does not currently expect to have to seek debt funding from sources other than the Facilities during the term of the Facilities.

The assessment of material prejudice, including the ability of each World Gym Entity to pay its creditors, embraces the whole transaction and so brings into account its immediate consequences in terms of determining whether there is a material prejudice. The assessment of material prejudice has both quantitative and qualitative elements.

The quantitative element involves an assessment of the impact of the Documents on the financial position, future profits and future cash flows of each World Gym Entity. If an obligor under the Facility Agreement (**Obligor**) fails to perform its obligations under or in connection with the Facility Agreement, CBA and/or the Security Trustee may decide to make a demand under the Facility Agreement (including by a call under a guarantee and indemnity and/or enforcement of security given by a World Gym Company). Accordingly, each World Gym Company will be liable for the default of the Obligor under the Facility Agreement.

The qualitative aspect requires an assessment of all the interlocking elements of the commercial transaction as a whole to determine where the net balance of financial

advantage lies. The directors of the Company consider that the acquisition of the shares in the capital of each World Gym Company is to the benefit of the World Gym Company and promotes the interests of the World Gym Company. This is on the basis that each World Gym Company will inherit a committed shareholder who will be focused on the performance of the World Gym Company and its business.

The directors of the Company do not currently have any reason to believe that:

- (a) the Obligors are likely to default in their obligations under the Facility Agreement; or
- (b) any World Gym Company is likely to default in its obligations under the Documents.

However, if CBA and/or the Security Trustee becomes entitled to enforce any of its rights under the Facility Agreement because an Obligor defaults, the enforcement may materially prejudice the interest of each World Gym Company and its shareholders. On enforcement, among other rights, the Security Trustee may become entitled to procure the sale of the assets of each World Gym Company. The sale of assets on enforcement may result in a return to a World Gym Company (and ultimately its shareholders) significantly lower than could have been achieved by the World Gym Company had those assets been sold other than in an enforcement scenario.

#### Shareholder approval of financial assistance

It is a requirement under section 260B(2) of the Corporations Act that if a World Gym Company will be a subsidiary of a listed domestic corporation (such corporation being the **Listed Holding Company**) immediately after the acquisition, the financial assistance must be approved by a special resolution passed at a general meeting of the Listed Holding Company.

Immediately after the acquisition of each World Gym Company, the Company became the Listed Holding Company of the World Gym Entity. Therefore, the Shareholders must approve the proposed financial assistance by each World Gym Company by special resolution passed at a general meeting in accordance with section 260B(2).

In addition, it is a requirement under section 260(B)(1)(b) of the Corporations Act that any proposed financial assistance to be given by a World Gym Company to acquire its own shares be approved by an ordinary resolution passed at a general meeting of the World Gym Company by all of its ordinary shareholders. The Directors will ensure that this requirement is satisfied prior to effecting the financial assistance.

The Board has unanimously approved the statements in this Explanatory Statement and recommends that the Shareholders approved the giving of the financial assistance and pass the Resolution under section 260B(2) of the Corporations Act.

The Directors consider that this Explanatory Statement contains all material information known to the Company that could reasonably be required by a Shareholder in deciding how to vote on Resolution 5, other than information that would be unreasonable to require the Company to disclose because the Company has previously disclosed that information to Shareholders.

#### **Directors' recommendation**

The Board unanimously recommends that Shareholders vote in favour of Resolution 5.
