The results of ASX Limited's Annual General Meeting held on 23 October 2025 are set out in the attached document.

All resolutions put to the AGM were decided by way of poll.

While more than 75% of votes cast on Resolution 3 were in favour of the adoption of the 2025 remuneration report, and a 'second strike' for the purposes of the *Corporations Act 2001* (Cth) was avoided, the conditional spill resolution was put to the meeting for prudence. The spill resolution was not effective due to the result of Resolution 3.
