Sixth Month Seaweed Sales Results – Record Growth and Operational Momentum

Highlights

- Gross sales of approximately A\$551,627 (IDR 5,930,000,000) for the October Sales Period (15 October – 14 November 2025).
- Highest monthly result to date, more than double the previous record month's total of A\$267,530 (July Sales Period).
- IDR 2,970,000,000 (approximately A\$276,744) in sales achieved directly by PT BPH Global, reflecting the strength of the Company's independent operations.
- IDR 2,960,000,000 (approximately A\$274,883) in sales completed under the Sales Cooperation Agreement with PT Kebula Raya Bestari.
- Significant operational efficiency gains through the Makassar warehouse and expanded sourcing network.
- Strong domestic demand and further progress toward international export shipments under the newly obtained Indonesian Seaweed Export Licence.

Results Overview

The Board of BPH Global Ltd (**ASX: BP8**) is pleased to announce another month of strong growth and record results from its Indonesian seaweed operations. A summary of all monthly trading results to date is provided in the sales performance table below.

For the period 15 October to 14 November 2025, BP8 generated gross sales of approximately A\$551,627 (IDR 5,930,000,000) based on fulfilled purchase orders with payments pending settlement under standard trading terms. This represents the highest monthly sales result to date, more than doubling the Company's previous best performance, and demonstrates accelerating commercial momentum in its Indonesia-based seaweed business.

Operations

BP8's Indonesian subsidiary, PT BPH Global Indonesia, delivered IDR 2,970,000,000 (A\$276,744) in independent sales during the October Sales Period, reflecting continued growth in its sourcing, processing, and distribution capabilities.

A further IDR 2,960,000,000 (A\$274,883) in sales were generated through the Company's ongoing collaboration with PT Kebula Raya Bestari under the existing Sales Cooperation Agreement.

This balanced outcome underscores the value of BP8's dual operational framework, with both sales channels performing strongly and supporting scalability across Indonesia's key seaweed-producing regions.

The Makassar warehouse operated by PT BPH Global Indonesia remains central to operations, enabling efficient processing, quality control, and logistics management. The combination of floor space and tailored infrastructure continues to deliver productivity and margin gains as trading volumes expand.

During the month, BP8 also progressed preparations for first direct export shipments from the Makassar warehouse, following the granting of its Indonesian Seaweed Export Licence. This milestone enables BP8 to ship seaweed products directly to overseas buyers, expected to drive further revenue growth and margin improvement in coming periods.

Outlook

Managing Director **Matthew Leonard** commented: "This month's results mark a major milestone for BP8, with total sales more than doubling our previous record and reflecting the strength of our dual operational model in Indonesia. The ability of PT BPH Global to generate nearly half of these results independently is a clear demonstration of our growing operational maturity and local market reach. With our export licence now in place and first direct international shipments imminent, BP8 is entering an exciting new phase of growth. We remain focused on expanding our customer base, scaling production, and building a sustainable, vertically integrated seaweed business that delivers long-term value for shareholders."

The Company will continue to provide monthly updates on sales volumes from its Indonesia-based seaweed operations.
