### **SEEK Chairman Succession**

SEEK Limited (**SEEK**) announces that the SEEK Board has appointed Greg Roebuck as a non-executive director from 1 January 2026 and Chairman-elect to succeed Graham Goldsmith from 1 March 2026, at which point Graham will retire from the Board. Greg will stand for election at the 2026 Annual General Meeting.

#### **Graham Goldsmith retirement**

Graham is retiring after 13 years as a director of SEEK and Chairman for the last seven of those years. He has led SEEK during a period of significant transformation and is retiring at a time when SEEK is in a strong position to deliver on its strategy, growth ambitions and create value for shareholders.

Graham said "It has been an honour and privilege to be a director and the Chairman of SEEK and to work with an outstanding Board, Management team and founder. In recent years, SEEK has undergone an important transformation, including simplification of the business structure, unification of technology platforms and APAC teams, advancing the use of AI to support our customers and improving discipline in investment decisions.

The Board, Management and SEEK's employees have worked hard to position SEEK as a leader in online employment marketplaces, with the foundations in place to deliver sustainable long-term earnings growth and value for stakeholders.

Importantly, during this time, SEEK has continued to focus on its long-term commitment to pursue its purpose, operate responsibly and enhance SEEK's unique culture."

#### **Greg Roebuck appointment**

Greg was the original architect and co-founder of CAR Group Limited. In his role as CEO, he led the transformation of the automotive sales industry in Australia and the significant growth of the company internationally.

Since then, Greg has served in non-executive and strategic positions such as Chairman of Pentana Solutions, non-executive Director at Walkinshaw Automotive Group Pty Ltd and Vic Roads, and as a partner in several investment funds. He has continued his focus on the technology industry and disciplined investment.

Graham Goldsmith said he was delighted that the Board had selected Greg, and with Greg's appointment as Chairman-elect.
