## Board retirement and committee changes

WiseTech Global Limited (ASX:WTC; WiseTech; the Company) provides an update on the retirement of Michael Gregg, and changes to the composition of the Audit & Risk Committee and the Chair of the Nomination Committee.

As previously announced on 19 June 2025, Michael Gregg had informed the Board that he intended to retire prior to the 2025 Annual General Meeting, as part of the Board renewal program. The Board confirms that Mr. Gregg's retirement will take effect as of the close of business today, Thursday 20 November 2025. The Board extends its sincere thanks and appreciation to Mr. Gregg for his many meaningful contributions to the growth and success of WiseTech, and for his dedicated service to the Company as a Director since 2006.

From the close of business today, the Audit & Risk Committee will comprise independent non-executive directors Andrew Harrison (Chair of the Audit & Risk Committee), Roberto Castaneda and Sandra Hook.

Additionally, from the close of business today, Andrew Harrison will assume the role of Chair of the Nomination Committee.

The Board is continuing to progress discussions with additional director candidates, with a view to announcing the appointment of at least one additional independent non-executive director by 31 December 2025.
