## **Share Purchase Plan Subscriptions**

**Sydney – 04 December 2025** – [BrainChip Holdings Ltd](#) (ASX: **BRN**, OTCQX: **BRCHF**, **BCHPY**), (“BrainChip” or the “Company”), the world’s first commercial producer of neuromorphic artificial intelligence IP, today announces that the Share Purchase Plan as originally announced to ASX on 10 November 2025, has closed with strong levels of interest resulting in subscriptions exceeding the original raise amount of \$2 million by \$0.976 million.

The SPP complemented the Company’s recently announced placement to institutional, professional and sophisticated investors to raise \$35.0 million (before costs) at an issue price of \$0.175 per share.

Given the strong shareholder support, and to minimise the dilution of shareholders who have been strong supporters of the Company, the BRN Board has exercised its discretion under the terms of the SPP to accept all applications received. The additional funds will be allocated in accordance with the intended use of funds outlined in the SPP Booklet released to ASX on 18 November 2025.

All shares will be allotted on 8 December 2025, with the dispatch of holding statements and quotation to occur on the same date.
