

## HAZER TO COLLABORATE WITH GLOBAL CHEMICALS FIRM KEMIRA ON INDUSTRIAL APPLICATIONS

### Highlights

- *Kemira is listed on the Nasdaq Helsinki with annual revenue of EUR2.95 billion (~AUD5.1b) in 2024*
- *Potential for commercial-scale deployment of Hazer's technology in chemicals industry in the Nordics*
- *Kemira to assess the feasibility of integrating Hazer's technology across its operations and test Hazer Graphite in water treatment*
- *Collaboration further confirms Hazer's position as a leading provider of methane pyrolysis technology*

**PERTH, AUSTRALIA; 15 January 2026:** Hazer Group Ltd ("Hazer" or "the Company") (ASX: HZR) is pleased to announce it has signed a non-binding Memorandum of Understanding ("MOU") with Kemira Oyj ("Kemira"), a global chemicals company serving water intensive industries, to evaluate and explore commercial opportunities for deployment of Hazer's proprietary methane pyrolysis technology.

Kemira is a global chemicals company headquartered in Finland and operating in more than 40 countries. Kemira is a world leader in sustainable chemical solutions for water-intensive industries including water treatment, pulp & paper and industrial processing. Kemira is listed on the Nasdaq Helsinki (HEL: KEMIRA) and had annual revenue of EUR2.95 billion (~AUD5.1 billion)<sup>1</sup> in 2024.

Under the MOU Hazer and Kemira will collaborate to evaluate the technical and commercial feasibility of deploying Hazer's technology and/or its products in Kemira's operations. Kemira will conduct testing of Hazer low emissions carbon in water treatment, as well as assessment of the feasibility of integration of Hazer's technology in industrial applications. Furthermore, if the initial assessments are positive, the parties have agreed to enter into discussions about commercial collaboration, including technology licensing and/or product offtake.

The MOU has an initial term of 1 year. Each party bears its own costs associated with the agreement.

**Hazer's CEO and MD Glenn Corrie said:** *"We are delighted to partner with Kemira, a global leader in sustainable chemical solutions for water intensive industries. This collaboration further validates Hazer's position as a leading provider of methane pyrolysis technology and highlights the growing interest in Hazer Graphite. We look forward to collaborating with Kemira to explore the potential for Hazer's world leading technology in the Nordics."*

**Kemira's EVP Research & Innovation Sampo Lahtinen said:** *"We have identified Hazer's technology to be very exciting and advanced, and we look forward to working with Hazer to investigate the integration of Hazer's innovative technology across Kemira's operations."*
