## VETERANS HEALTH ADMINISTRATION CONTRACT UPDATE

Mach7 Technologies Limited (“M7T” or “the Company”) (ASX:M7T), a company specialising in innovative medical imaging software solutions advises that the Prime Vendor for the Veterans Health Administration (VHA) contract has received notification indicating the VHA will cease the NextGen PACS<sup>1</sup> program for the National Teleradiology Program (NTP) as originally conceived.

Mach7 has been advised by the prime vendor that a Partial Stop Work Order from the VHA is underway to cease the current multi-vendor NextGen PACS program. The VHA is expected to remain with its incumbent vendor.

On 3 July 2023, Mach7 announced that it would participate in the VHA’s NextGen PACS program as one of several subcontractors to a prime vendor. Mach7 was to provide its Vendor Neutral Archive (VNA) and eUnity Enterprise Diagnostic Viewer as part of this contract.

On 31 October 2025, Mach7 announced it had completed initial milestones for a limited go-live in mammography and telestroke. Since then, Mach7 has met its obligations in relation to the implementation of Phase 1 of this contract. Phase 2 was contingent on Phase 1 and with this decision by the VHA, neither will proceed.

Mach7 CEO and Managing Director Teri Thomas said: “While the VHA decision is disappointing, the NextGen PACS program was a uniquely complex, bespoke government implementation requiring significant resources. Importantly, this outcome does not affect our strategy and allows us to focus on our commercial pipeline where deal velocity and payment terms are more straightforward. Mach7 will continue the disciplined execution of its strategy to support ongoing ARR growth and profitability.”
