<p>Answer: Operating cash flow includes several exceptional, one-off outflows unrelated to in-quarter operations, primarily prior-period payments, annual incentive payments, and prepayments for events and other contractual commitments in Q2 and Q3. Excluding these items, underlying quarterly operating cash flow would have been an outflow of \$0.3m. The business also benefits from seasonal cash inflows in Q2 and Q3, driven by scheduled events and contractual receipts on service delivery, which are expected to improve operating cash flow.</p>

<p>Answer: The company has guided the market that the business will be cash generative from Q3 and reiterates that guidance.</p>	

8.6.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, the business is performing in line with plan and expects additional upside in Q2. It is significantly ahead of prior year results in advertising, Nexus and events for H1, with strong year-on-year growth forecast across these areas for the half.
