Energy One financial results for half year ended 31 December 2025

Energy One growth strategy delivers positive operating leverage

25 February – Sydney, Australia: Energy One Ltd (ASX: EOL), a leading global provider of wholesale energy trading software and services, today announced its financial results for the 6 months ended 31 December 2025 (H1 FY26).

FY25 financial snapshot relative to prior corresponding period (pcp)¹

- Total revenue of \$34.8m up 21%
- ARR of \$64.0m, up 20%
- Underlying cash EBITDA of \$7.3m, up 63% and underlying cash EBITDA margin of 21%, up 3 percent points v H2 FY 2026
- Underlying NPAT of \$4.5m (statutory NPAT of \$4.0mil), up 56%
- Net debt of \$5.8m, a reduction of \$7.2m

Commenting on the results, Energy One CEO Shaun Ankers said: “The Energy One team has successfully delivered growth in revenues and ARR in-line with our expectations, accompanied by further improvements in cash EBITDA margins as we continue our trajectory towards 30%.

In addition, we generated strong cashflows and reduced our net debt, providing the stability and flexibility to support future growth.

This is my final results announcement as CEO, and I would like to thank all EOL employees for their hard work and dedication in building the company into what it is today. I would also like to thank the EOL Board for their guidance during my tenure, and our shareholders for their trust and support.

I look forward to continuing to support EOL in a different capacity and to handing over the baton to Ben, in whom I have the utmost confidence.”

Ben Tranier, CEO Designate commented: “I am thrilled to be taking on the role of CEO of Energy One. Shaun and the EOL team have built a high-quality company with significant growth opportunities ahead. I am honoured to be entrusted with leading EOL and the team into the future.
