## Completion of CannPal Asset Acquisition and Neuvis® Option

### Highlights:

- **Argent completes acquisition of CannPal animal epilepsy asset from AusCann Group Holdings Ltd**
- **Transaction includes option to acquire Neuvis® drug delivery platform**
- **CannPal provides Phase 3 veterinary epilepsy programme with near-term commercial potential**
- **Acquisition strengthens CannEpil® clinical, regulatory, and data positioning**

**Argent BioPharma Ltd (ASX: RGT) (Argent or the Company)** is pleased to confirm that, following shareholder approval at the recent General Meeting, it has completed the acquisition of AusCann Group Holdings Ltd's interest in CannPal Animal Therapeutics Pty Ltd (**CannPal**), together with an option to acquire the Neuvis® drug delivery platform.

### About CannPal

CannPal is a veterinary pharmaceutical development programme focused on the treatment of epilepsy in companion animals, with its lead asset targeting seizure management in dogs. The programme has progressed through advanced clinical development and is currently positioned at Phase 3, with a defined regulatory pathway and potential for near-term commercialisation.

The CannPal dataset, including clinical and safety data generated to date, provides a valuable translational foundation that supports Argent BioPharma's broader neurological strategy, particularly in relation to CannEpil® and seizure-related indications

### Strategic Value to Argent BioPharma

The acquisition represents a targeted expansion of the Company's neurological and epilepsy-focused portfolio.

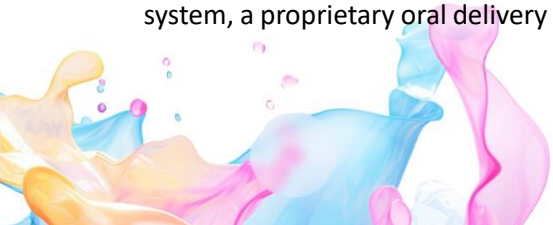
Key strategic benefits include:

### Neuvis® Option

As part of the transaction, Argent BioPharma has secured an option to acquire the Neuvis® drug delivery system, a proprietary oral delivery platform designed to enhance bioavailability and formulation performance.

Neuvis® has the potential to be applied across multiple assets within the Company's pipeline, supporting future product optimisation, lifecycle extension, and intellectual property consolidation.

### Strategic Significance

The completion of this acquisition marks a significant milestone in Argent BioPharma's development strategy, reinforcing its position as a neuro-immune focused biopharmaceutical company with both human and veterinary applications.

The addition of CannPal expands the Company's asset base with a late-stage programme capable of generating independent revenue, while also enhancing the scientific and regulatory framework underpinning CannEpil®.

This transaction further strengthens the Company's intellectual property position and aligns its portfolio with the requirements and scale expected of a U.S. national exchange listing.

### Argent BioPharma Managing Director and CEO, Roby Zomer, Commented:

*"The completion of the CannPal acquisition represents a strategically aligned step in strengthening Argent BioPharma's neurological portfolio. By adding a late-stage epilepsy programme with standalone commercial potential, while enhancing the data and positioning around CannEpil®, we are reinforcing both the depth and coherence of our asset base. The inclusion of the Neuvis® option further adds platform-level optionality as we continue to build a scalable and IP-driven pipeline aligned with our U.S. growth strategy."*
