To receive and consider the Financial Report, the Directors' Report and the Auditor's Report for the financial year ended 31 December 2025 (as set out in the Annual Report 2025).

Resolution 1: Adoption of Remuneration Report

To consider and if thought fit, pass the following resolution as an ordinary resolution:

"That, for the purposes of section 250R(2) of the Corporations Act 2001 (Cth) and for all other purposes, the Remuneration Report for the financial year ended 31 December 2025, as set out in the Directors' Report section of the Annual Report, be adopted."

Note: Under the Corporations Act, the vote on this Resolution is advisory only and does not bind the Directors or the Company.

Voting Exclusion Statement for Resolution 1

In accordance with the *Corporations Act 2001* (Cth) (**Corporations Act**), a vote must not be cast on Resolution 1 in any capacity (and will be taken not to have been cast if contrary to this restriction) by or on behalf of a member of the Key Management Personnel (**KMP**), details of whose remuneration are included in the Remuneration Report, and any Closely Related Party of such a member.

However, the member or Closely Related Party of such a member may vote if:

- (a) it is cast by a person as a proxy appointed by writing that specifies how the proxy is to vote on the resolution, or by a person who is the chair of the meeting at which the resolution is voted on and the appointment does not specify the way the proxy is to vote on the resolution and expressly authorises the chair to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the KMP; and

Note: Ms Reed is a current Director and Chair of the Audit & Risk Committee of the Company. The Directors of the Company (excluding Ms Reed who abstains from making a recommendation) RECOMMEND that Shareholders vote in favour of this Resolution.

However, this does not apply to a vote cast in favour of these Resolution 3 by:

- a person as proxy or attorney for a person who is entitled to vote on the resolutions, in accordance with the directions on the proxy or attorney to vote on the resolutions in that way; or
- the chair of the meeting as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with a direction given to the chair to vote on the resolution as the chair decides; or
- a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary; provided the following conditions are met:

The Company will disregard any votes cast on this Resolution by any person who is eligible to participate in, or who will obtain a material benefit as a result of, the proposed issue (except a benefit solely by reason of being a holder of ordinary securities in the Company) (namely the Placement Participants), and any associates of those persons.

However, this does not apply to a vote cast in favour of these Resolution 4 by:

- a person as proxy or attorney for a person who is entitled to vote on the resolutions, in accordance with the directions on the proxy or attorney to vote on the resolutions in that way; or

Voting Exclusion Statement for Resolution 5

The Company will disregard any votes cast on this Resolution by any person who is eligible to participate in, or who will obtain a material benefit as a result of, the proposed issue (except a benefit solely by reason of being a holder of ordinary securities in the Company) (namely the Lead Manager Limited), and any of its associates.

However, this does not apply to a vote cast in favour of these Resolution 5 by:

- a person as proxy or attorney for a person who is entitled to vote on the resolutions, in accordance with the directions on the proxy or attorney to vote on the resolutions in that way; or
- the Chairman as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with a direction given to the chair to vote on the resolution as the chair decides; or
- a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary; provided the following conditions are met:
 - the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an associate of a person excluded from voting on the resolution; and
 - the holder votes on the resolution in accordance with directions given by the beneficiary to the holder to vote in that way.

Note: The Directors of the Company RECOMMEND that Shareholders vote in favour of this Resolution.

Resolution 6: Approval of Additional 10% Placement Capacity

To consider and, if thought fit, pass the following resolution as a special resolution:

“That, for the purpose of Listing Rule 7.1A and for all other purposes, approval is given for the issue of Equity Securities (or enter into agreements to issue Equity Securities) totalling up to 10% of the issued capital of the Company, calculated in accordance with the formula prescribed in Listing Rule 7.1A.2 and on the terms and conditions set out in the Explanatory Statement.”

Resolution 6 is a Special Resolution requiring at least 75% of the votes cast by Shareholders entitled to vote on Resolution 6 to be in favour of the Resolution for it to pass.

Voting Exclusion Statement for Resolution 6

As set out in Listing Rule 7.3A.7, a voting exclusion in respect of an approval under Listing Rule 7.1A is only required if, at the time of dispatching the Notice, the entity is proposing to make an issue of Equity Securities under Listing Rule 7.1A.2. As the Company is not proposing to make an issue of Equity Securities under that Listing Rule as at the time of dispatching the Notice, no voting exclusion statement is required for Resolution 6.

Note: The Directors of the Company RECOMMEND that Shareholders vote in favour of this Resolution.

Resolution 7: – Issue of Rights to Tino Guglielmo, Managing Director

To consider and, if thought fit, to pass the following Resolution as an ordinary resolution:

“That, for the purpose of Listing Rule 10.14 and for all other purposes, the issue to Tino Guglielmo (or his nominee) of performance rights pursuant to the Company’s equity incentive plan as described in the Explanatory Statement be approved.”

Voting Exclusion Statement for Resolution 7

In accordance with the Listing Rules, the Company will disregard any votes cast in favour of Resolution 7 by or on behalf of Mr Guglielmo and any of his Associates (and any other person referenced in Listing Rules 10.14.1, 10.14.2 or 10.14.3 who is eligible to participate in the Equity Incentive Plan and any of their associates).

However, the Company will not disregard a vote cast in favour of Resolution 7 by:

- (a) a person as a proxy or attorney for a person who is entitled to vote on Resolution 7, in accordance with the directions given to the proxy or attorney to vote on Resolution 7 in that way; or
- (b) the Chair as proxy or attorney for a person who is entitled to vote on Resolution 7, in accordance with a direction given to the Chair to vote on Resolution 7 as the Chair decides; or
- (c) a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
 - (i) the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an Associate of a person excluded from voting, on Resolution 7; and
 - (ii) the holder votes on Resolution 7 in accordance with directions given by the beneficiary to the holder to vote in that way.

Note: The Directors of the Company (excluding Mr Guglielmo who abstains from making a recommendation) RECOMMEND that Shareholders vote in favour of this Resolution.

Resolution 8: Spill Resolution (Conditional Item)

If required, to consider and if considered appropriate, to pass the following resolution as an ordinary resolution:

“That subject to and conditional on at least 25 percent of the votes validly cast on Resolution 1 (Adoption of the Remuneration Report) being cast against the adoption of the Remuneration Report for the year ended 31 December 2025:

- (a) another general meeting of the Company (**Spill Meeting**) be held within 90 days after the passing of this resolution;
- (b) all of the Non-Executive Directors who were in office when the resolution to approve the Remuneration Report for the year ended 31 December 2025 was considered and

- who remain in office at the time of the Spill Meeting will cease to hold office immediately prior to the end of the Spill Meeting; and*
- (c) *resolutions to appoint persons to offices that will be vacated immediately before the end of the Spill Meeting be put to the vote of shareholders at the Spill Meeting.”*

Voting Exclusion Statement for Resolution 8

A vote must not be cast on resolution of KMP, or a closely related party of a KMP, acting as proxy, if their appointment does not specify the way the proxy is to vote on resolution. However, this voting exclusion does not apply if the KMP is the Chairman acting as proxy and their appointment expressly authorise the Chairman to exercise the proxy even if the Resolution 8 is connected directly or indirectly with the remuneration of a member of the KMP of the Company.

If you appoint the Chairman as your proxy, and you do not direct your proxy how to vote on Resolution 8 on the proxy form, you will be expressly authorising the Chairman to exercise your proxy even if Resolution 8 is connected directly or indirectly with the remuneration of a member of the KMP of the Company, which includes the Chairman.

Note – The Directors unanimously RECOMMEND that vote against this Resolution.

Chair acting as proxy

Shareholders may appoint the Chair of the meeting as their proxy.

Where the Chair is appointed as a proxy by a shareholder entitled to cast a vote on a particular resolution and the proxy form specifies how the Chair is to vote on the resolution (that is, a directed proxy), the Chair must vote in accordance with that direction.

In respect of proxies where no voting direction has been given (undirected proxies), the Chair intends to vote all available proxies in favour of each resolution.

Voting prohibition by proxy holders

To the extent required by section 250BD of the Corporations Act, a person appointed as a proxy must not vote, on the basis of that appointment, on Resolutions 1 or 7 if the person is either a member of the Company's KMP or a closely related party of such a member and the appointment does not specify the way the proxy is to vote on the relevant Resolution. However, the proxy may vote if the proxy is the Chair and the appointment expressly authorises the Chair to exercise the proxy even if the Resolution is connected directly or indirectly with the remuneration of a member of the Company's KMP.

If the Chair is appointed as your proxy and you have not specified the way the Chair is to vote on any Resolution by signing and returning the Proxy Form (including via an online facility), you are considered to have provided the Chair with an express authorisation for the Chair to vote

the proxy in accordance with the Chair's intention, even though the Resolution is connected directly or indirectly with the remuneration of a member of the Company's KMP.

2. Entitlement to vote at the meeting

For the purpose of the meeting, shares in the Company will be taken to be held by those persons who are registered holders at 7.00pm AEST on Tuesday, 12 May 2026. Accordingly, transactions registered after that time will be disregarded in determining entitlements to attend and vote at the meeting.

3. Quorum

The Constitution of the Company provides that five or more members present at the meeting and entitled to vote on a resolution at the meeting will constitute a quorum.

Terms and abbreviations used in this Notice and the Explanatory Statement are defined in Section J below.

EXPLANATORY STATEMENT

This Explanatory Statement has been prepared to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the resolutions which are the subject of the business of the Meeting.

Capitalised terms in this Explanatory Statement are defined in Section J below.

The Financial Report, the Directors' Report and the Auditor's Report for the financial year ended 31 December 2025 (contained in the Annual Report 2025).

Shareholders have been notified that the Company's Annual Report for the year ended 31 December 2025 (**Annual Report 2025**) can be found on the Company's website (www.bassoil.com.au) under 'Investor Centre – Annual Reports' and have been given the option of having a printed copy of the Report sent to them. The Annual Report 2025 has been sent to those Shareholders who requested it.

Annual Report

In accordance with section 317 of the Corporations Act, Shareholders will be offered the opportunity to discuss the Annual Report, including the financial report for the year ended 31 December 2025, the Directors' Report, and the Auditor's Report.

There is no requirement for Shareholders to approve the Annual Report.

At the Meeting, Shareholders will be offered the opportunity to:

- (a) discuss the Annual Report;
- (b) ask questions about, or comment on, the management of the Company; and
- (c) ask the auditor questions about the conduct of the audit, the preparation and content of the Auditor's Report, accounting policies adopted by the Company and the independence of the auditor.

In addition to taking questions at the Meeting, written questions to the Company's auditor about:

- (d) the content of the Auditor's Report; and
- (e) the conduct of the audit,

may be submitted no later than 5 business days before the Meeting to the Company Secretary at the Company's registered office.

A. Resolution 1 - Adoption of Remuneration Report

The Company is required under Section 250R(2) of the Corporations Act to include, in the business of its AGM, a resolution that the Remuneration Report for the financial year ended 31 December 2025 be adopted.

The Remuneration Report which forms part of the Directors Report is set out on pages 20 to 27 of the Annual Report 2025.

Under section 250R(3) of the Corporations Act, the vote is advisory only and does not bind the Directors or the Company. Accordingly, if this Resolution is not passed, the Directors will not be required to alter any of the arrangements set out in the Remuneration Report. However, the

Directors will take into account the outcome of the vote when reviewing the Company's remuneration policies and practices.

In accordance with Division 9 of Part 2G.2 of the Corporations Act, if at least 25% of the votes cast on the Resolution are voted against adoption of the Remuneration Report at the 2026 Annual General Meeting and then again at the 2026 annual general meeting, the Company will be required to put to Shareholders a resolution at the 2026 annual general meeting proposing the calling of a further general meeting to consider the election of Directors of the Company (**Spill Resolution**).

If more than 50% of Shareholders vote in favour of a Spill Resolution, the Company would be required to convene a further general meeting (**Spill Meeting**) within 90 days of the 2026 annual general meeting. All of the Directors who were in office when the 2026 Directors' Report was approved by the Directors (other than the Managing Director) would cease to hold office immediately before the end of the Spill Meeting but may, if eligible, stand for re-election at the Spill Meeting. Following the Spill Meeting, those persons whose election or re-election as Directors is approved would (together with the Managing Director) be the Directors of the Company.

Key Management Personnel, details of whose remuneration are included in the Remuneration Report, and their closely related parties are prohibited from voting on this Resolution, except in the circumstances described in the voting exclusion set out in the Notice.

The Chair will allow a reasonable opportunity for Shareholders at the Meeting to ask about, or make comments on, the Remuneration Report.

Voting Exclusion

The Voting Exclusion Statement is set out under the Resolution in the Notice of Meeting.

Directors' Recommendation

Acknowledging that each Director has a personal interest in his or her own remuneration from the Company, as described in the Remuneration Report, the Directors unanimously **RECOMMEND** the adoption of the Remuneration Report.

B. Resolution 2 – Re-election of Ms Laura Ann Reed as a Director

The Constitution of the Company requires that at every Annual General Meeting one-third, or the next highest number nearest one-third, of the Directors shall retire from office and provides that such Director(s) are eligible for re-election at the meeting.

Ms Reed has been a Non-Executive Director of the Company since 18 December 2023.

Ms Reed is a finance professional with more than 35 years of experience in the energy sector, and she has previously held the following positions:

- Chief Financial Officer, Chief Executive Officer and Managing Director of Spark Infrastructure Group;
- Chief Financial Officer of Envestra Ltd;
- Non-Executive Director of ATCO Australia and Canadian Utilities Limited;
- Chair of both the Spark Infrastructure Group and Epic Energy South Australia Pty Ltd.
- board member of the Clean Energy Finance Corporation (which assists with the funding of clean energy projects).

Ms Reed served as Chair of the Audit and Risk Committee since joining the Board of Directors.

If re-elected, the Directors considers that Ms Reed will qualify as an independent Non-Executive Director, and that Ms Reed's independence had not been impaired during her tenure.

Voting Exclusion

The Voting Exclusion Statement is set out under the Resolution in the Notice of Meeting.

Directors' Recommendation

The Directors (excluding Ms Reed who abstains from making a recommendation) **RECOMMEND** that Shareholders vote in favour of Resolution 2.

C. Resolutions 3 and 4 – Background to resolutions

Placement

The Company announced on 16 March 2026 that it is issuing new shares to sophisticated/professional investors at a price of \$0.063 per share (**Placement**). The total number of shares to be issued under the placement is 47,619,048 (**Placement Shares**) and these will be issued under Listing Rule 7.1. On 24 March 2026, 47,619,048 Placement Shares were issued raising \$3,000,000 (before costs). The issue price represents:

- a 13% discount to the last closing price of Shares prior to the announcement of the Placement; and
- a 25% discount to the 15-day volume weighted average price (VWAP) of the Company's shares for the period ending 11 March 2026.

The Placement includes the issue of 23,809,524 free Options. The participants in the Placement (**Placement Participants**) will be offered one (1) option for every two (2) Placement Share issued, subject to the approval of Shareholder at this meeting (**Placement Options**). The Placement Options will have an exercise price of \$0.0945 expiring two years after issue. If Shareholder do not approve the issue of Placement Options, the Placement Participants will not receive Placement Options as part of the Placement.

The Placement Options are not currently traded on the ASX, however the Company intends to seek approval at quotation of the Placement Options subject to conditions being met.

Use of funds

The proceeds raised from the Placement will be applied to funding as follows:

- (1) the Completion of the acquisition of the Vanessa gas field and facilities;
- (2) drilling of the Bunian 6 oil development well in Indonesia;
- (3) recommissioning of the Vanessa gas field, facilities and pipeline;
- (4) progressing the Kiwi liquids rich gas project to a Final Investment Decision; and
- (5) meeting corporate costs and general working capital needs.

D. Resolution 3 - Approval to Ratify the Prior issue of Placement Shares – Listing Rule 7.1A

Resolution 3 seeks approval to ratify the prior issue of 47,619,048 Placement Shares made on 24 March 2026.

ASX Listing Rule 7.1 provides that a listed company may only issue or agree to issue up to 15% of the company's ordinary issued capital in any 12 month period, unless shareholder approval is obtained (subject to certain exceptions).

ASX Listing Rule 7.4 allows a listed company in a general meeting to subsequently approve an issue of securities for the purpose of ASX Listing Rule 7.1, provided the company did not breach ASX Listing Rule 7.1.

By ratifying the prior issue 47,619,048 Placement Shares, the Company will retain the flexibility to issue equity securities in the future within the limits of ASX Listing Rules 7.1 up to its 15% capacity, without needing to seek further Shareholder approval. If Resolution 3 is not passed, the Company's ability to issue new securities without shareholder approval will be restricted until the previous issue/s are ratified at a subsequent meeting or 12 months from the date of issue of the Placement Shares

Technical information required by Listing Rule 7.5

ASX Listing Rule 7.5 requires the following information to be provided to Shareholders for the purposes of obtaining Shareholder approval pursuant to ASX Listing Rule 7.4:

- (a) The number of securities the entity issued
47,619,048 Placement Shares were issued under ASX Listing Rules 7.1.
- (b) The issue price of the securities
The Placement Shares were issued at an issue price of \$0.063.
- (c) The date of issue of securities
The Placement Shares were issued on 24 March 2026.
- (d) The terms of the securities
The Placement Shares rank equally with all Shares currently on issue.
- (e) The names of the allottees (or the basis on which the allottees were determined)
The Placement Shares were issued to non-related party investors, who were sophisticated and professional investors introduced to the Company to subscribe for the Placement Shares by its lead manager, PAC Partners Securities Limited
- (f) The intended use of the funds raised
The funds raised from the issue of the Placement Shares will be applied to funding:
 - (i) the Completion of the acquisition of the Vanessa gas field and facilities;
 - (ii) drilling of the Bunian 6 oil development well in Indonesia;
 - (iii) recommissioning of the Vanessa gas field, facilities and pipeline;
 - (iv) progressing the Kiwi liquids rich gas project to a Final Investment Decision; and
 - (v) meeting corporate costs and general working capital needs.

Technical information required by Listing Rule 14.1A

If Resolution 3 is passed, the Company will be able to exclude the 47,619,048 Placement Shares when calculating the Company's 15% annual placement capacity.

If Resolution 3 is not passed, the Company will be unable to exclude the 47,619,048 Placement Shares when calculating the Company's 15% annual placement capacity.

Voting Exclusion

The Voting Exclusion Statement is set out under the Resolution in the Notice of Meeting.

Directors' Recommendation

The Directors **RECOMMEND** that Shareholders vote in favour of Resolution 3.

E. Resolution 4 – Approval to issue Placement Options to Placement Participants

General

As set out above, investors who participated in the Placement will have the right to subscribe for one Placement Option for every two Placement Shares subscribed for and issued under the Placement.

The Placement Options are each exercisable at \$0.0945 and expire 2 years after their issue. The Placement Options will be offered under a “transaction specific prospectus” prepared in accordance with section 713 of the Corporations Act, which the Company will shortly lodge with the ASX.

Accordingly, Resolution 4 seeks Shareholder approval for purposes of Listing Rule 7.1 for the issue of up to 23,809,524 Placement Options.

Technical information required by Listing Rule 14.1A

If Resolution 4 is passed, the Company will be able to proceed with the issue of Placement Options, and the issue of the Placement Options will not use up any of the Company’s 15% annual placement capacity.

If Resolution 4 is not passed, the Company will not be able to proceed with the issue of Placement Options.

Technical information required by Listing Rule 7.3

Pursuant to and in accordance with Listing Rule 7.3 the following information is provided in relations to Resolution 4:

- (a) The number of securities the entity will issue
Up to 23,809,524 Placement Options (subject to rounding).

The full terms of the Placement Options are set out in Schedule 1 to this Notice.

- (e) Date of issue
The Placement Options will be issued within 3 months of Shareholder approval being obtained by the Company (or otherwise, as determined by the ASX in the exercise of their discretion).
- (f) The intended use of the funds raised
Funds will not be raised from the issue of the Placement Options as the Placement Options are issued as free attaching options on the basis of 1 free Placement Options for every 2 Placement Shares issued.

The Voting Exclusion Statement is set out under the Resolution in the Notice of Meeting.

Directors’ Recommendation

The Directors **RECOMMEND** that Shareholders vote in favour of Resolution 4.

F. Resolution 5 – Approval to issue Lead Manager Options

General

PAC Partners Securities Pty Ltd (**PAC Partners**) acted as the lead manager of the Placement pursuant to the mandate agreement entered into by the Company and PAC Partners. Under that agreement, the Company agreed, subject to shareholder approval being obtained, to issue to PAC Partners one (1) option to subscribe for shares in the Company for every six (6) Placement Shares subscribed for and issued under the Placement, on the same terms as the Placement Options (**Lead Manager Options**).

Accordingly, Resolution 5 seeks Shareholder approval for purposes of Listing Rule 7.1 for the issue of 7,936,508 Lead Manager Options to PAC Partners.

Technical information required by Listing Rule 14.1A

If Resolution 5 is passed, the Company will be able to proceed with the issue of the Lead Manager Options, and the issue of the Lead Manager Options will not use up any of the Company's 15% annual placement capacity.

If Resolution 5 is not passed, the Company will not be able to proceed with the issue of the Lead Manager Options to PAC Partners.

Technical information required by Listing Rule 7.3

Pursuant to and in accordance with Listing Rule 7.3 the following information is provided in relations to Resolution 4:

- (a) The number of securities the entity will issue
7,936,508 Lead Manager Options.
- (b) The issue price of the securities
Each of the Lead Manager Options will be issued for nil consideration.

The Lead Manager Options will be issued within 3 months of Shareholder approval being obtained by the Company (or otherwise, as determined by the ASX in the exercise of their discretion).
- (f) The intended use of the funds raised
Funds will not be raised from the issue of the Lead Manager Options as the Lead Manager Options are issued as free options on the basis of 1 free Lead Manager Option for every 6 Placement Shares issued.

Voting Exclusion

The Voting Exclusion Statement is set out under the Resolution in the Notice of Meeting.

Directors' Recommendation

The Directors **RECOMMEND** that Shareholders vote in favour of Resolution 5.

G. Resolution 6 – Approval of Additional 10% Placement Capacity

Broadly speaking, and subject to a number of exceptions, Listing Rule 7.1 limits the number of Equity Securities that a listed company can issue without the approval of its shareholders over

any 12 month period to 15% of the fully paid ordinary securities it had on issue at the start of that period.

ASX Listing Rule 7.1A provides that an 'Eligible Entity' may seek Shareholder approval, by way of a special resolution at its annual general meeting to increase the 15% limit under Listing Rule 7.1 by an extra 10%, to 25% (**10% Placement Capacity**).

The Company is an Eligible Entity and is now seeking shareholder approval by way of special resolution to have the ability to issue Equity Securities under the 10% Placement Capacity.

The effect of Resolution 6, if passed, will be to allow the Company to issue Equity Securities up to an additional 10% of the Company's fully paid ordinary securities on issue under the 10% Placement Capacity during the period up to 12 months after the Meeting, without subsequent Shareholder approval and without using the Company's 15% annual placement capacity granted under Listing Rule 7.1. The exact number of Equity Securities which may be issued under the 10% Placement Capacity will be determined in accordance with the formula prescribed in ASX Listing Rule 7.1A.2.

Resolution 6 is a special resolution. Accordingly, at least 75% of votes cast on Resolution 6 by Shareholders eligible to vote at the Meeting must be in favour of Resolution 6 for it to be passed.

ASX Listing Rule 7.1A

ASX Listing Rule 7.1A enables an Eligible Entity to seek shareholder approval at its annual general meeting to issue Equity Securities in addition to those under the Eligible Entity's 15% annual placement capacity.

An Eligible Entity is one that, as at the date of the relevant annual general meeting:

- (a) is not included in the S&P/ASX 300 Index; and
- (b) has a maximum market capitalisation (excluding restricted securities and securities quoted on a deferred settlement basis) of \$300,000,000.

The Company is an Eligible Entity as it is not included in the S&P/ASX 300 Index and has a market capitalisation as at 7 April 2026 of \$23,855,386.

Any Equity Securities issued must be in the same class as an existing class of quoted Equity Securities. As at the date of this Notice, the Company has two classes of Equity Securities on issue, being Shares (ASX Code: BAS) and Options (ASX Code: BASOA). The exact number of Equity Securities that the Company may issue under an approval under Listing Rule 7.1A will be calculated according to the formula set out in Listing Rule 7.1A.2.

Technical information required by ASX Listing Rule 7.1A

Pursuant to and in accordance with ASX Listing Rule 7.3A, the information below is provided in relation to this Resolution 6:

(a) ***Minimum Price***

The minimum price at which the Equity Securities may be issued under Listing Rule 7.1A (which must be for cash consideration) is 75% of the volume weighted average market price of Equity Securities in that class, calculated over the 15 ASX trading days on which trades in that class were recorded immediately before:

- (i) the date on which the price at which the Equity Securities are to be issued is agreed; or
- (ii) if the Equity Securities are not issued within 10 ASX trading days of the date in paragraph (a)(i) above, the date on which the Equity Securities are issued.

(b) **Date of Issue**

The Equity Securities may be issued under the 10% Placement Capacity commencing on the date of the Meeting and expiring on the first to occur of the following:

- (i) 12 months after the date of this Meeting;
- (ii) the time and date of the Company's next annual general meeting; and
- (iii) the date of approval by Shareholders of any transaction under ASX Listing Rules 11.1.2 (a significant change to the nature or scale of the Company's activities) or 11.2 (disposal of the Company's main undertaking),

or such longer period if allowed by ASX (**10% Placement Capacity Period**).

(c) **Risk of voting dilution**

If this Resolution is approved by Shareholders at the Meeting and the Company issues Equity Securities under the 10% Placement Capacity, the existing Shareholders' economic interest may be diluted if the Equity Securities are issued at a discount. Further, the existing Shareholders' voting power in the Company will be diluted by up to 9.09% if all of the Listing Rule 7.1A capacity is used. There is a risk that:

- (i) the market price for the Company's Equity Securities may be significantly lower on the date of the issue of the Equity Securities than on the date of Shareholder approval at the Meeting; and
- (ii) the Equity Securities may be issued at a price that is at a discount to the market price for the Company's Equity Securities on the issue date,

which may have an effect on the amount of funds raised by the issue of the Equity Securities and also on the Company's Share price post issue of the Equity Securities.

The table below shows the dilution of existing Shareholders on the basis of the current Share price and the current number of Shares for variable "A" calculated in accordance with the formula in Listing Rule 7.1A(2) as at the date of this Notice.

The table also shows:

- (i) two examples where variable "A" has increased, by 50% and 100%. Variable "A" is based on the number of Shares the Company has on issue. The number of Shares on issue may increase as a result of issues of Shares that do not require Shareholder approval (for example, a pro-rata entitlement offer or scrip issued under a takeover offer) or future specific placements under Listing Rule 7.1 that are approved by Shareholders at this Meeting or at future Shareholder meetings; and
- (ii) two examples where the issue price of Shares has changed – in one example it has decreased by 50% and in another it has increased by 50% against the current Share price (which, for the purposes of this table, is \$0.065).

 - (iv) the circumstances of the Company, including, but not limited to, the financial position and solvency of the Company;
 - (v) prevailing market conditions; and
 - (vi) advice from corporate, financial and broking advisers (if applicable).
- (f) **Previous Approval under ASX Listing Rule 7.1A**

The Company did not obtain Shareholder approval under ASX Listing Rule 7.1A at the Annual General Meeting held on 15 May 2025. The following information is provided in accordance with Listing Rule 7.3A.6:

No shares have been issued under Listing Rule 7.1A.2 in the 12 months preceding the date of this Meeting.

- (g) **Voting Exclusion**

As at the date of this Notice, the Company has not invited any existing Shareholder to participate in an issue of Equity Securities under ASX Listing Rule 7.1A. Therefore, no existing Shareholders will be excluded from voting on Resolution 6.

Directors' Recommendation

The Directors **RECOMMEND** that Shareholders vote in favour of Resolution 6.

H. Resolution 7 - Issue of Rights to Tino Guglielmo, Managing Director

Background

The Bass Oil Performance Rights Plan (**Incentive Plan**) was established to incentivise personnel to provide (and reward them for providing) dedicated and ongoing commitment and effort to the Company, and to align the interests of personnel and Shareholders in order to increase Shareholder value by enabling those persons to share in the future growth and profitability of the Company. The Board considers that the ability to issue incentive rights and/or options as incentives to the Company's personnel provides a necessary mechanism to attract, retain and motivate personnel to achieve the Company's goals.

The Board considers that its senior executives should be remunerated in a manner that encourages them to become Shareholders as this is the best mechanism to align their interests with those of the Company's Shareholders. It is the Company's policy that the performance based

(that is, at risk) pay of senior executives is to form a component of their total remuneration. Granting incentives under a long-term incentive plan seeks to encourage and reward long-term sustainable performance.

A summary of the material terms of the Incentive Plan and the Performance Rights to be issued under the Incentive Plan is set out in Schedule 2.

The Company is proposing to issue a total of 1,650,000 Performance Rights under the Incentive Plan to the Company's Managing Director, Mr Guglielmo (or his nominee) (**Performance Rights Issue**). Each Performance Right will be exercisable into one Share if the performance conditions set out in Schedule 3 have been met during the measurement period.

If Resolution 7 is passed, the Performance Rights will be issued in accordance with an invitation made by the Board pursuant to the terms of the Incentive Plan. If Resolution 7 is not passed, the Company will not be able to proceed with the issue of Performance Rights under the Incentive Plan and the Company will consider alternative remuneration arrangements to remunerate and incentivise Mr Guglielmo appropriately and align his interests with the long term success of the Company.

Purpose of approval sought

Listing Rule 10.11 requires a listed entity to obtain shareholder approval for the issue of securities to related parties, which includes a director of the listed entity.

Listing Rule 10.12, Exception 8 provides that approval under Listing Rule 10.11 is not required for an issue of Equity Securities under an employee incentive scheme made, or taken to have been made, with the approval of the issuing entity's shareholders under Listing Rule 10.14.

Listing Rule 10.14 provides that a listed company must not permit a director (or certain other persons) to acquire Equity Securities under an employee incentive scheme unless it obtains the approval of its shareholders.

The Performance Rights Issue falls within Listing Rule 10.14 and therefore requires the approval of Shareholders. Resolution seeks the required Shareholder approval to issue the Performance Rights to Mr Guglielmo for the purposes of Listing Rule 10.14.

Mr Guglielmo, as Managing Director of the Company, is entitled to participate in the Incentive Plan. The Board considers that the issue of Performance Rights to Mr Guglielmo, or to his nominee, under the Incentive Plan is in the Company's interests as it further aligns the interests of Mr Guglielmo with the interests of Shareholders in order to maximise Shareholder value. Further, the Performance Rights Issue provides cost effective remuneration to Mr Guglielmo in his role and will assist in retaining his services, which the Board considers to be important to the future success of the Company.

The proposed Performance Rights Issue constitutes an equity-based incentive for Mr Guglielmo and the Performance Rights will lapse 18 months after the date on which they are issued.

The Board has considered the Performance Rights Issue and, taking into account the circumstances of the Company and its Subsidiaries, the circumstances of Mr Guglielmo, and the remuneration practices of other similar entities, considers that the financial benefits provided to Mr Guglielmo by way of the Performance Rights (together with the other elements of his remuneration package) constitutes reasonable remuneration. Accordingly, approval under Chapter 2E of the Corporations Act is not being sought.

If Resolution 7 is passed, the Company will be able to proceed with the proposed issue of Performance Rights to Mr Guglielmo and issue up to a total of 1,650,000 Performance Rights to Mr Guglielmo or his nominee.

If Resolution 7 is not passed, the Company will not be able to proceed with the proposed issue of Performance Rights to Mr Guglielmo.

For the purposes of Listing Rule 10.15, the following information is provided to Shareholders in relation to these Resolutions:

- (a) The persons to acquire the Performance rights under the Incentive Plan is Mr Tino Guglielmo (or his nominee). Mr Guglielmo is the Managing Director of the Company.
- (b) Mr Guglielmo falls within Listing Rule 10.14.1, being a Director of the Company. His nominee (if applicable) would fall within Listing Rule 10.14.2, being an associate of Mr Guglielmo.
- (c) The maximum number of Performance Rights that may be acquired by Mr Guglielmo (or his nominee) under the Incentive Plan pursuant to Resolution 7 is 1,650,000 Performance Rights.
- (d) The current total remuneration package for Mr Guglielmo is \$392,000 per annum (base salary and superannuation) as at 1 January 2026, and \$6,275 has been provided for long service leave.
- (e) 1,650,000 Performance Rights have been previously issued to Mr Guglielmo under the Incentive Plan. None of those rights vested by reason of a failure to satisfy their Performance Conditions and have subsequently lapsed.
- (f) A summary of the material terms of the Performance Rights to be issued under the Incentive Plan is set out in Schedule 3. Performance Rights are being used to provide cost effective remuneration as an incentive, alignment and retention tool for Mr Guglielmo. Each Performance Right will be exercisable into one Share if the Performance Conditions set out below have been met during the measurement period. The indicative value of each Performance Right to be issued to Mr Guglielmo is \$0.026 using a Monte Carlo Approach pricing model. This valuation was undertaken by the Company based on the following assumptions:

- (g) It is proposed that Mr Guglielmo (or his nominee) will be issued the Performance Rights within 12 months (and in any event no later than 3 years) after the date of the Meeting.
- (h) The Performance Rights will be issued to Mr Guglielmo (or his nominee) for nil cash consideration, as part of his remuneration package.
- (i) A summary of the material terms of the Incentive Plan is set out in Schedule 2.
- (j) No loan will be provided in relation to the acquisition of the Performance Rights.
- (k) Details of any Performance Rights issued under the Incentive Plan will be published in the annual report of the Company relating to the period in which they were issued, along with a statement that approval for the issue was obtained under Listing Rule 10.14.

(l) Any additional persons covered by Listing Rule 10.14 who become entitled to participate in an issue of Performance Rights under the Incentive Plan after the Resolution is approved and who were not named in the Notice will not participate until approval is obtained under that Listing Rule.

(m) A voting exclusion statement in respect of Resolution 7 is set out in the Notice.

If approval is given under Listing Rule 10.14, approval is not required under Listing Rule 7.1.

Directors' Recommendation

The Directors (excluding Mr Guglielmo who abstains from making a recommendation) **RECOMMEND** that Shareholders vote in favour of Resolution 7.

I. Resolution 8 – Spill Resolution (Conditional Item)

Note: This resolution will only be put to a vote if at least 25% of the votes cast on the resolution to adopt the Remuneration Report (Resolution 1) are cast against the adoption of the report. Such an against vote will constitute a second strike for the Company.

Under the *Corporations Act 2001* (Cth), if at least 25% of the votes validly cast on a resolution to adopt the Remuneration Report at two consecutive Annual General Meetings are against the resolution, Shareholders must be given an opportunity to vote on a spill resolution meeting at the second Annual General Meeting. This is known as the two strikes rule.

At Bass's 2025 Annual General Meeting, more than 25% of votes cast on the resolution to adopt the FY25 Remuneration Report were cast against adopting that report and Bass received a first strike. The resolution set out in Resolution 8 is a spill resolution and will only be put to the Annual General Meeting if Bass receives a second strike on its Remuneration Report. If fewer than 25% of the votes are cast against its adoption, then there will be no second strike and Resolution 7 will not be put to the Annual General meeting. If this resolution is put to the Annual General meeting, it will be considered an ordinary resolution.

If the resolution is put to a vote, it is **NOT SUPPORTED** by the Board.

Consequences of the spill resolution being passed by Shareholders

If Resolution 8 is put to the Annual general meeting and is passed (i.e. by a majority of more than 50% of votes), the Company will be required to hold a meeting of Shareholders, known as a Spill Meeting, to consider the composition of the Bass Oil Limited Board. The Spill Resolution must be held within 90 days of the Annual General Meeting.

If the following Non-Executive Directors of Bass Oil Limited remain in office at the time of the Spill Meeting, they will automatically cease to hold office unless they are re-elected at the Spill Meeting:

- Mr Hector Gordon
- Ms Laura Reed

Even if Ms Laura Reed is re-elected at the Annual General Meeting, she will need to be confirmed at the Spill Meeting to remain in office.

Considerations for deciding how to vote on Resolution 8

The Board considers the following factors to be relevant to a Shareholder's decision on how to vote on Resolution:

- The Board has taken the first strike against the FY 25 Remuneration report very seriously, actively engaging with Shareholders and reviewing remuneration policies and award structures with a view to addressing Shareholder concerns.
- The Board's view is that it currently has the right mix of skills and experience.
- Holding a Spill Meeting would create significant disruption and uncertainty. Furthermore, if the Spill Meeting occurred and the above Non-Executive Directors were not returned to office, it could take considerable time to rebuild the Board with the same skills and experience as the current group of Non-Executive Directors. Further changes to the Board and uncertainty in the renewal of Non-Executive Directors which could result from the Spill Meeting are not in the best interest of Bass Oil or its Shareholders.
- Each Non-Executive Director listed above has previously been elected as a Director with the strong support of Shareholders.
- Convening a Spill meeting will incur significant costs to Bass Oil, which the Board does not consider to be in the best interest of Bass Oil Shareholders.

If it is required to be put to the meeting, the Board unanimously recommends Shareholders vote **AGAINST** this resolution.

Determining the number of Performance Rights eligible to vest

After the end of each Measurement Period, the Board will determine the extent to which the applicable Performance Conditions have been satisfied and the subsequent proportion of the Performance Rights that will be eligible to vest.
