



# NATIONAL STORAGE REIT ASX ANNOUNCEMENT

15 April 2026

## Results of Meetings

National Storage REIT (ASX:NSR) (**NSR**) is pleased to announce that the requisite majorities of NSR securityholders today voted in favour of the Transaction Resolutions to approve the proposed unstapling of NSR securities, the trust scheme and the share scheme of arrangement (**Schemes**) pursuant to which entities established and jointly indirectly owned by a consortium of the Brookfield Funds (being funds owned or managed by Brookfield Asset Management Ltd or its affiliates and their managed funds) and affiliates of the GIC Investor, will acquire all of the issued NSR securities (**Transaction**).<sup>1</sup>

### Voting results

In accordance with ASX Listing Rule 3.13.2 and section 251AA(2) of the *Corporations Act 2001* (Cth), the results of the poll for each of the five Transaction Resolutions are set out in the table annexed to this announcement. In summary:

- **Voting results of Share Scheme Meeting:** the resolution to approve the share scheme of arrangement (Share Scheme Resolution), as set out in the Notice of Share Scheme Meeting dated 10 March 2026 (in Annexure E of the Scheme Booklet), was passed by the requisite majorities of NSR Securityholders, with:
  - 88.47% of NSR Securityholders present and voting (either in person or by proxy, attorney or corporate representative) in favour of the Share Scheme Resolution; and
  - 97.91% of votes cast in favour of the Share Scheme Resolution.
- **Voting results of Trust Scheme Meeting:** the two resolutions to approve the trust scheme, as set out in the Notice of Trust Scheme Meeting dated 10 March 2026 (in Annexure E of the Scheme Booklet), were passed by the requisite majorities of NSR Securityholders, with:
  - in respect of the first Trust Scheme Resolution (Amendment of National Storage Trust Constitution), 97.92% of votes cast in favour of the resolution; and
  - in respect of the second Trust Scheme Resolution (Acquisition of National Storage Units), 97.91% of votes cast in favour of the resolution.
- **Voting results of General Meeting of National Storage Shareholders:** the resolution to approve the Unstapling of National Storage Shares from National Storage Units (Company Unstapling Resolution), as set out in the Notice of General Meeting of National Storage Shareholders dated 10 March 2026 (in Annexure E of the Scheme Booklet), was passed by the requisite majorities of NSR Securityholders, with 97.92% of votes cast in favour of the Company Unstapling Resolution.

- **Voting results of General Meeting of National Storage Unitholders:** the resolution to approve the Unstapling of National Storage Units from National Storage Shares (Trust Unstapling Resolution), as set out in the Notice of General Meeting of National Storage Unitholders dated 10 March 2026 (in Annexure E of the Scheme Booklet), was passed by the requisite majorities of NSR Securityholders, with 97.92% of votes cast in favour of the Trust Unstapling Resolution.

## Second Court Hearing

The Schemes remain subject to the approval of the Supreme Court of New South Wales (**Court**) in order to be implemented and certain other conditions precedent as described in section 10.1.2 of the Scheme Booklet.

NSR will apply to the Court for orders approving the Share Scheme and for the provision of the Second Judicial Advice in relation to the Trust Scheme at a hearing scheduled for 9.15am (Sydney time) on Tuesday, 21 April 2026 (**Second Court Date**) at the Law Courts Building, 184 Phillip Street, Queens Square, Sydney NSW 2000.

NSR will make a further announcement after the Court has considered the matter.

## Lodgement of Court Orders and Suspension of Trading

If the Court approves the Share Scheme and grants the Second Judicial Advice in relation to the Trust Scheme, NSR proposes to lodge an office copy of the Court orders and the executed Supplemental Deed with the Australian Securities and Investments Commission on the Second Court Date (Tuesday, 21 April 2026), at which time the Schemes will become legally Effective.

If this occurs, it is expected that NSR securities will be suspended from trading on the ASX from close of trading on Tuesday, 21 April 2026.
