Results of 2026 Annual General Meeting of Stockholders

Coronado Global Resources Inc (“Coronado” or the “Company”, ASX: CRN) held its Annual General Meeting of Stockholders today and in accordance with Listing Rule 3.13.2 is pleased to announce that each of the following resolutions, as set out in the Notice of Meeting dated 22 April 2026 (US Eastern Time) were passed on a poll by the relevant security holders:

Ordinary Resolution by Holder of Preferred Stock Series A (Coronado Group LLC)

- Proposal 1: Election of Series A Director Ms Laura Tyson

Ordinary Resolutions by Holders of Common Stock

- Proposal 2: Election of Mr Garold (Gerry) Spindler; Ms Aimee R. Allen; Mr Philip Christensen; Mr Greg Pritchard; and Ms Jan C. Wilson;
- Proposal 3: Approval on a non-binding advisory basis of the Company's named executive officers' compensation;
- Proposal 4: That the Company will hold the non-binding, advisory vote on named executive officer compensation every three years;
- Proposal 5: Ratification of appointment of Ernst and Young, the Company's independent registered public accounting firm for fiscal year ending December 31, 2026; and
- Proposal 6: Approval of issuance of 90,000,000 Securities under the Company's Equity Incentive Plan.

The final proxy voting and poll results as provided by Computershare are set out in the two reports attached to this announcement. The reporting has been provided based on Computershare's U.S based voting categories. Relevantly, the proxy votes received before the meeting were equal to the poll result. The total number of securities voted and the percentage of that total number of securities that were voted on the proposal they represented are identified as, respectively, 'Voted' and 'Voted (%)' in those reports.

The first report provides the results of voting by Coronado Group LLC, voting as a separate class, representing 1 share of the Company's preferred stock Series A, par value \$0.01 per share (“Series A Share”).

The second report provides the results of voting by the common stockholders, voting as a separate class. CDI holders must have instructed CHESS Depository Nominees Pty Ltd (“CDN”) as the shareholder of record, to vote the common shares underlying their CDIs; and no other third-party proxy could be appointed.

In relation to the number of eligible votes noted in those reports, for context, there is a total of 167,645,373 shares of common stock on issue; 90,337,269.4 of which are held as CDIs (equivalent to 1,676,453,730 CDIs in total), as set out in the following table:

*These figures represent the common stock over which Coronado Group LLC holds legal ownership (on the assumption that all shares of common stock on issue are held as CDIs). In addition, Coronado Group LLC owns beneficially a further 71,980,369 CDIs in our company (accordingly, held by CDN on behalf of Coronado Group LLC) bringing Coronado Group LLC's total ownership in the Company (legal and beneficial) to 845,061,399 CDIs, or 84,506,139.9 shares of common stock.
