## Results of General Meeting of Shareholders

Patrys Limited (ASX: PAB) (Patrys, or the “Company”) held its General Meeting (GM) of Shareholders of the Company today, 8 June 2026, at Level 2, 7 Havelock Street, West Perth WA 6005.

Resolutions 1 to 9 were passed on a poll.

In accordance with ASX Listing Rule 3.13.2 and Section 251AA of the Corporations Act 2001, details of proxies and poll votes cast for each resolution are attached.

The Company also advises that, due to an administrative oversight, the proposed participation of Mr Brian Leedman, Non-Executive Director of the Company, in the placement announced on 20 April 2026 was not included in the Notice of Meeting and was therefore not considered by Shareholders at the General Meeting.

The Company intends to seek Shareholder approval at its Annual General Meeting for Mr Brian Leedman to participate in the placement, comprising 2,083,333 shares and 520,833 options, on the same terms as the placement shares and options issued to the other participating Directors.
