Request for Voluntary Suspension

Cynata Therapeutics Limited (“**Cynata**” or “the **Company**”) (ASX:CYP) requests a voluntary suspension of its quoted securities to apply from the open of trading today, Tuesday 16 June 2026.

The voluntary suspension is requested pending material announcements by Cynata in relation to the results of the Phase 3 Osteoarthritis Trial (**OA Trial**) and Phase 2 Graft versus Host Disease Trial (**GvHD Trial**).

Cynata expects to announce the results of the OA Trial and the GvHD Trial on or before Friday, 20 June 2026.

In accordance with Listing Rule 17.2, Cynata provides the following information:

- (a) the voluntary suspension is requested pending the release by Cynata of the results of the OA Trial and the GvHD Trial;
- (b) the Company requests that the voluntary suspension remain in place until the earlier of the Company making announcements in relation to the OA Trial and the GvHD Trial and the commencement of trading on Friday, 19 June 2026;
- (c) the Company is not aware of any reason why the voluntary suspension should not be granted; and
- (d) the Company is not aware of any other information necessary to inform the market about the voluntary suspension.

About Cynata Therapeutics (ASX: CYP)

Cynata Therapeutics Limited (ASX: CYP) is an Australian clinical-stage stem cell and regenerative medicine company focused on the development of therapies based on Cymerus™, a proprietary therapeutic stem cell platform technology. Cymerus™ overcomes the challenges and limitations of conventional MSC production by using induced pluripotent stem cells (iPSCs) to achieve economic manufacture of cell therapy products, including mesenchymal stem cells (MSCs), at commercial scale without the necessity to obtain tissue from multiple donors on an ongoing basis, and without the complexity and product inconsistency resulting from conventional methods.

Cynata has demonstrated positive safety and efficacy data for its Cymerus™ product candidates CYP-001 and CYP-006TK in Phase 1 clinical trials in steroid-resistant acute graft versus host disease (GvHD) and diabetic foot ulcers (DFU), respectively. Further



clinical trials are now ongoing: a Phase 2 trial of CYP-001 in GvHD under a cleared US FDA IND; a Phase 1/2 trial of CYP-001 in patients undergoing kidney transplantation; and a Phase 3 trial of CYP-004 in osteoarthritis. In addition, Cynata has demonstrated utility of its Cymerus™ technology in preclinical models of numerous other diseases, including critical limb ischaemia, idiopathic pulmonary fibrosis, asthma, heart attack, sepsis, acute respiratory distress syndrome (ARDS) and cytokine release syndrome.
