Healius transitions pathology arrangements with subsidiary entities of Ramsay Health Care

Healius Limited (ASX: HLS) (**Healius** or **Company**) today announced that it has entered into a national agreement framework with wholly-owned subsidiaries of Ramsay Health Care Limited (ASX:RHC) (**Ramsay subsidiaries**). Effective on and from 1 July 2026, Healius' existing pathology leases and service arrangements with the Ramsay subsidiaries, will be transitioned into the national agreement framework. See **Annexure 1** for details of the contracting parties and impacted hospitals.

Healius is the incumbent provider of pathology services for both public and private patients at thirteen hospitals operated by Ramsay Health Care in New South Wales, Western Australia, Victoria and Queensland. Under the arrangements, there is no change to Healius' pathology services at the thirteen hospitals. Instead, the new national framework transitions the existing arrangements into a uniform set of agreements.

The new agreements with the Ramsay subsidiaries will be for initial terms of between two and five years. Total annual revenue under the initial terms of the new agreements is expected to be approximately \$45m, based on continued customer demand consistent with no significant changes in economic conditions.

Healius Managing Director and Chief Executive Officer, Paul Anderson, said: "We are honoured that Ramsay Health Care has renewed its pathology arrangements with Healius and are delighted to continue our work with Ramsay to deliver timely, consistent, quality pathology services to meet the needs of Ramsay hospital practitioners and patients."
