Proteomics International signs national distribution agreement with Healius for Promarker® portfolio

Highlights

- National distribution agreement executed with Healius Limited (ASX: HLS) as the exclusive pathology distribution partner for the Promarker® portfolio in Australia.
- Initial term of three years, with an option to extend for a further three years by mutual agreement.
- Proteomics International will continue to perform all testing through its accredited laboratory infrastructure and provide clinical reporting.
- Provides access to Healius' national pathology network, including more than 2,000 patient collection centres and established referrer relationships.
- Establishes the Company's first national distribution partnership for commercial implementation of the Promarker® portfolio across Australia.
- Implementation activities will commence immediately, with phased commercial rollout planned during FY27.

Agreement Overview

Proteomics International Laboratories Ltd (ASX: PIQ) ("Proteomics International" or "the Company") is pleased to announce that it has entered into a national Australian distribution agreement with Healius Limited (ASX: HLS) ("Healius"), appointing Healius as the exclusive pathology distribution partner for the Promarker® portfolio and establishing the Company's first national commercial distribution partnership.

Under the agreement, Healius has been appointed the exclusive Australian pathology distribution partner for the Company's Promarker® portfolio of predictive and diagnostic blood tests for an initial term of three years, with an option to extend the agreement for a further three years by mutual agreement.

Proteomics International will continue to perform all testing through its accredited laboratory infrastructure and provide clinical reporting, while Healius will utilise its pathology distribution infrastructure to support specimen collection, pathology distribution and market access across Australia.

The agreement provides Proteomics International with access to Healius' collection centre network, comprising more than 2,000 patient collection centres and established relationships with general practitioners, specialists, hospitals and other healthcare providers throughout Australia.

Proteomics International will retain responsibility for the Promarker® portfolio, including laboratory testing, clinical reporting, scientific and medical support, quality and regulatory compliance. Healius will be responsible for pathology distribution through its national infrastructure, including specimen collection, referrer engagement, market access activities and support for the Promarker® portfolio.

The parties will work collaboratively on implementation and commercial rollout activities, with each organisation continuing to focus on its respective areas of expertise.

The agreement represents the first national commercial distribution partnership secured for the Promarker® portfolio and establishes a national distribution pathway for commercial implementation across Australia. It is intended to support national access to the Promarker® portfolio through existing pathology collection and distribution infrastructure without requiring Proteomics International to establish its own national specimen collection network.

As the Promarker® portfolio is at an early stage of commercialisation, the revenue that may be generated under the distribution agreement cannot be reliably estimated at this time. The Company will update the market on material developments in accordance with its continuous disclosure obligations.

The commercial terms of the agreement are confidential.

Commercial Significance

The agreement establishes the Company's preferred Australian commercialisation model for the Promarker® portfolio. Proteomics International will retain responsibility for laboratory testing, scientific support, quality systems and clinical reporting, while leveraging Healius' established pathology distribution infrastructure and referrer relationships. The Company believes this model supports capital-efficient market access and commercial implementation of the Promarker® portfolio.

Commentary

Proteomics International Chief Executive Officer and Managing Director, David Morris, said:

"This agreement provides a national distribution pathway for the Promarker® portfolio and represents an important step in our commercialisation strategy. By partnering with Healius, we can leverage an established pathology network while maintaining responsibility for laboratory testing, reporting and clinical support."

"By combining Proteomics International's accredited laboratory capability with Healius' pathology distribution infrastructure, we have established a scalable pathway to support the phased rollout of the Promarker® portfolio across Australia."

"We look forward to working closely with Healius to support clinician awareness and adoption activities for the Promarker® portfolio."

Next Steps

The parties will immediately commence implementation activities, including operational integration, information technology integration, laboratory workflow implementation, clinician education and engagement, market access planning and commercial launch preparation.

Implementation will occur in a phased manner, with commercial rollout expected to commence progressively during FY27 following completion of implementation activities.

Promarker® Portfolio

Promarker®D – Diabetic Kidney Disease

Promarker®D is a predictive blood test designed to identify people with type 2 diabetes who are at increased risk of developing chronic kidney disease before conventional clinical indicators become apparent, supporting earlier clinical intervention and more personalised patient management.

Promarker®Eso – Oesophageal Cancer Risk Assessment

Promarker®Eso is a blood test designed to assist in identifying patients with chronic gastro-oesophageal reflux disease and Barrett's oesophagus who may be at increased risk of developing oesophageal cancer, supporting earlier investigation and informed clinical decision-making.

Promarker®Endo – Endometriosis

Promarker®Endo is a diagnostic blood test designed to assist clinicians in the diagnosis of endometriosis and support earlier identification of the condition.
