# Explanatory Statement

This Explanatory Statement has been prepared for the information of the Shareholders in connection with the business to be conducted at the General Meeting to be held at 11:00 am (AEST) on 26 August 2026 at the Ground Floor Business Centre, 365 Little Collins Street, Melbourne, VIC, 3000 (Meeting).

The purpose of this Explanatory Statement is to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions in the Notice of Meeting.

If you are in any doubt about what to do in relation to the Resolutions contemplated in the Notice of Meeting and this Explanatory Statement, it is recommended that you seek advice from an accountant, solicitor or other professional advisor.

Full details of the business to be considered at the General Meeting are set out below.

## Background to the Placement

In March 2026 the Company completed a private placement raising a total of \$730,000 (before costs) from the issue of 121,666,667 (Placement Shares) at \$0.006 per Share with 1 free attaching unlisted Option for every 2 Placement Shares subscribed for and issued, exercisable at \$0.01 each and expiring 30 June 2029 (Placement Options) (Placement).

The Placement is being undertaken in the following tranches:

- 53,728,164 Placement Shares issued to unrelated parties on 13 March 2026 using the Company's available placement capacity under Listing Rule 7.1;
- 62,938,503 Placement Shares issued to unrelated parties of the Company on 13 March 2026 using the Company's available placement capacity under Listing Rule 7.1A;
- 58,333,334 Placement Options to be issued to unrelated parties of the Company subject to Shareholders approving Resolution 2 (Placement Options); and
- 5,000,000 Placement Shares (Director Placement Shares) and 2,500,000 Placement Options (Director Placement Options) (Director Placement Securities) to be issued subject to Shareholders approving Resolution 3.

The Company engaged Sanlam Private Wealth Pty Limited (Lead Manager) as lead manager and broker to the Placement. The Lead Manager will receive a cash fee of 6% of funds raised under the Placement and 25,000,000 Options (Lead Managers Options). Lead Managers Options will be issued subject to Shareholders approving Resolution 4.

# Resolutions

## Resolution 1 – Ratification of prior issue of Placement Shares

### General

The background to the Placement, including the prior issue of the Placement Shares is set out in previously in this Explanatory Statement.

Resolutions 1(a) and 1(b) seeks Shareholder approval pursuant to Listing Rule 7.4 to ratify the issue of the Tranche 1 Placement Shares under Listing Rule 7.1 and 7.1A respectively.

#### 1.1 Listing Rules 7.1, 7.1A and 7.4

Broadly speaking, and subject to a number of exceptions, Listing Rule 7.1 limits the amount of Equity Securities that a listed company can issue without the approval of its shareholders over any 12-month period to 15% of the fully paid ordinary shares it has on issue at the start of that period.

Under Listing Rule 7.1A however, an eligible entity can seek approval from its members, by way of a special resolution passed at its annual general meeting, to increase this 15% limit by an extra 10% to 25%. The Company obtained this approval at its annual general meeting held on 25 November 2025.

The issue of the Tranche 1 Placement Shares does not fit within any of the exceptions to Listing Rule 7.1 and 7.1A and, as it has not yet been approved by Shareholders, effectively uses up part of the Company's 15% placement capacity under Listing Rule 7.1 and 10% placement capacity under Listing Rule 7.1A. This reduces the Company's capacity to issue further Equity Securities without Shareholder approval under those Listing Rules for the 12 month period following the issue of the Tranche 1 Placement Shares.

Listing Rule 7.4 provides an exception to Listing Rules 7.1 and 7.1A. It provides that where a company in a general meeting ratifies the previous issue of securities made pursuant to Listing Rule 7.1 and 7.1A (and provided the previous issue did not breach Listing Rule 7.1 and 7.1A), those securities will be deemed to have been made with shareholder approval for the purposes of Listing Rule 7.1 and 7.1A.

The effect of Shareholders passing 1(a) and 1(b) will be to allow the Company to retain the flexibility to issue Equity Securities in the future up to the 15% placement capacity set out in Listing Rule 7.1, and the 10% additional placement capacity set out in Listing Rule 7.1A, without the requirement to obtain prior Shareholder approval.

If Resolution 1(a) is passed, 53,728,164 Tranche 1 Placement Shares will be excluded in calculating the Company's 15% limit under Listing Rule 7.1, effectively increasing the number of Equity Securities it can issue without Shareholder approval over the 12 month period following the issue of those Tranche 1 Placement Shares.

If Resolution 1(b) is passed, 62,938,503 Tranche 1 Placement Shares will be excluded in calculating the Company's 10% limit under Listing Rule 7.1A, effectively increasing the number of Equity Securities it can issue without Shareholder approval over the 12 month period following the issue of those Tranche 1 Placement Shares.

If Resolution 1(a) is not passed, 53,728,164 Tranche 1 Placement Shares will continue to be included in the Company's 15% limit under Listing Rule 7.1, effectively decreasing the number of Equity Securities the Company can issue or agree to issue without obtaining prior Shareholder approval, to the extent of 53,728,164 Equity Securities for the 12 month period following the issue of those Tranche 1 Placement Shares.

If Resolution 1(b) is not passed, 62,938,503 Tranche 1 Placement Shares will continue to be included in the Company's 10% limit under Listing Rule 7.1A, effectively decreasing the number of Equity Securities the Company can issue or agree to issue without obtaining prior Shareholder approval, to the extent of 62,938,503 Equity Securities for the 12 month period following the issue of those Tranche 1 Placement Shares (and assuming the Company's approval under Listing Rule 7.1A remains in force for this period).

The Company confirms that Listing Rules 7.1 and 7.1A were not breached at time the Tranche 1 Placement Shares were issued.

## 1.2 **Specific information required by Listing Rule 7.5**

Pursuant to and in accordance with Listing Rule 7.5, the following information is provided in relation to the ratification of the issue of the Tranche 1 Placement Shares:

- The Placement Shares were issued to a range of new and existing sophisticated and professional investors (**Placement Participants**). The Placement Participants were identified through a bookbuild process, which involved the Lead Manager seeking expressions of interest to participate in the Placement from new and existing contacts of the Company and clients of the Lead Manager. None of the Placement Shares the subject of Resolutions 1(a) and 1(b) were issued to related parties or Material Investors of the Company.
- On 13 March 2026, the Company issued a total of 116,666,667 Placement Shares using the Company's available placement capacity in the following proportions:
  - (i) 53,728,164 Tranche 1 Placement Shares issued under Listing Rule 7.1; and
  - (ii) 62,938,503 Tranche 1 Placement Shares issued under Listing Rule 7.1A.
- The Placement Shares are fully paid ordinary shares in the capital of the Company and rank equally in all respects with the Company's existing Shares on issue.
- The Tranche 1 Placement Shares were issued at \$0.006 each.
- The proceeds from the issue of the Tranche 1 Placement Shares have been and are intended to be used for working capital and to fast-track additional sampling at Aurora, the Company's porphyry gold prospect located in Arizona, USA to define drilling targets for the September quarter.
- There are no other material terms to the agreement for the issue of the Placement Shares.
- A voting exclusion statement is included in the Notice.

### 1.3 Additional Information

Resolutions 1(a) and 1(b) are separate ordinary resolutions.

The Board recommends that Shareholders vote in favour of Resolutions 1(a) and 1(b).

## **Resolution 2 - Approval to issue 58,333,334 Placement Options under Listing Rule 7.1**

### **Background**

The background of the Placement and Placement Options is set out in previously in this Explanatory Statement.

Resolution 2 seeks the approval of Shareholders pursuant to and in accordance with Listing Rule 7.1 to issue the Placement Options.

### **Listing Rule 7.1**

A summary of Listing Rules 7.1 is set out previously in this Explanatory Statement.

The issue of the Placement Options does not fit within any of the exceptions to Listing Rule 7.1. It therefore requires the approval of the Company's Shareholders under Listing Rule 7.1.

The effect of Shareholders passing Resolution 2 will be to allow the Company to retain the flexibility to issue Equity Securities in the future up to the 15% placement capacity set out in Listing Rule 7.1 without the requirement to obtain prior Shareholder approval.

If Resolution 2 is passed, the Company can proceed to issue the 58,333,334 Placement Options without using up any of the Company's 15% limit on issuing Equity Securities without shareholder approval under Listing Rule 7.1, effectively increasing the number of Equity Securities it can issue without Shareholder approval over the 12-month period following the issue date.

If Resolution 2 is not passed, the Company will not be able to proceed with the issue of the 58,333,334 Placement Options. As at the date of this Notice, the Company does not have sufficient placement capacity to issue the 58,333,334 Placement Options. Accordingly, the Company will not be able to proceed with the issue if Resolution 2 is not passed unless it has sufficient placement capacity following the Meeting.

### **Specific information required by Listing Rule 7.3**

Pursuant to and in accordance with Listing Rule 7.3, the following information is provided in relation to Resolution 2:

- The Placement Options will be issued to the participants in the placement who include new and existing shareholders, sophisticated and professional investors and clients of the Lead Manager who are not related parties of the Company. No Material Investors, KPM, substantial shareholders or advisors to the Company will receive Options pursuant to this Resolution 2.
- A maximum of 58,333,334 Placement Options will be issued pursuant to this Resolution.

- The Placement Options are exercisable at \$0.01 each and expire 30 June 2029 and are otherwise subject to the terms and conditions set out Schedule 1.
- The Placement Options will be issued no later than 3 months after the date of the Meeting.
- The Placement Options are being issued as free attaching Options to the Placement Shares. Accordingly, nil additional cash consideration will be payable for the Placement Options.
- No additional funds will be raised by the issue of the Placement Options. Any funds raised upon exercise of the Placement Options will be used to fund drilling and exploration expenditure and for general working capital purposes.
- There are no other material terms to the proposed issue of the Placement Options.
- A voting exclusion statement is included in the Notice.

### **Additional information**

Resolution 2 is an ordinary resolution.

The Board recommends that Shareholders vote in favour of Resolution 2.

## **Resolution 3 – Approval to issue Director Placement Securities**

### **General**

The background to the Placement is set out earlier in this Explanatory Statement.

Company Director Francesco Cannavo intends to participate in the Placement to the extent of subscribing for up to 5,000,000 Director Placement Shares and 2,500,000 Director Placement Options to raise up to \$30,000 (before costs).

Resolutions 3 seeks Shareholder approval pursuant to Listing Rule 10.11 for the issue of the Director Placement Securities to Francesco Cannavo (or his respective nominees).

### **Listing Rule 10.11**

Listing Rule 10.11 provides that unless one of the exceptions in Listing Rule 10.12 applies, a listed company must not issue or agree to issue Equity Securities to any of the following persons without the approval of its Shareholders:

- a related party (Listing Rule 10.11.1);
- a person who is, or was at any time in the 6 months before the issue or agreement, a substantial holder (30%+) in the company (Listing Rule 10.11.2);
- a person who is, or was at any time in the 6 months before the issue or agreement, a substantial holder (10%+) in the company and who has nominated a director to the board of the company pursuant to a relevant agreement which gives them a right or expectation to do so (Listing Rule 10.11.3);
- an associate of a person referred to in Listing Rules 10.11.1 to 10.11.3 (Listing Rule 10.11.4); or

- a person whose relation with the company or a person referred to in Listing Rule 10.11.1 or 10.11.4 is such that, in ASX's opinion, the issue or agreement should be approved by its shareholders (Listing Rule 10.11.5).

Francesco Cannavo is a related party of the Company by virtue of being a Director. Shareholder approval pursuant to Listing Rule 10.11 is therefore required unless an exception applies. It is the view of the Board that the exceptions set out in Listing Rule 10.12 do not apply in the current circumstances.

Approval pursuant to Listing Rule 7.1 is not required for the issue of the Director Placement Securities as approval is being obtained under Listing Rule 10.11. Accordingly, the issue of the Director Placement Securities to the Directors (or their respective nominees) will not be included in the Company's 15% annual placement capacity pursuant to Listing Rule 7.1.

The effect of Shareholders passing Resolution 3 will be to allow the Company to issue the Director Placement Securities, raising up to \$30,000 (before costs).

If Resolution 3 is not passed, the Company will not be able to proceed with the issue of the Director Placement Securities and will not receive the additional \$30,000 (before costs) committed by the Director.

### **Specific information required by Listing Rule 10.13**

Pursuant to and in accordance with Listing Rule 10.13, the following information is provided in relation to the proposed issue of the Director Placement Securities:

- The Director Placement Options will be exercisable at \$0.01 each and will expire 30 June 2029. The Director Placement Options are subject to the terms and conditions in Schedule 1.
- The Director Placement Securities will be issued within one month after the date of the Meeting.
- The Director Placement Shares are proposed to be issued at an issue price of \$0.006 each, being the same issue price as other Placement Shares and will raise \$30,000 (before costs).
- The Director Placement Options are proposed to be issued for nil cash consideration as they are free-attaching to the Director Placement Shares (on a one Option for every two Shares basis). Accordingly, no funds will be raised from the issue of the Director Placement Options. Any funds raised upon exercise of the Director Placement Options will be used to fund drilling and exploration expenditure and for general working capital purposes.
- Funds raised from the issue of Director Placement Shares will be used for working capital purposes and to fund additional sampling at Aurora, the Company's gold prospect located in Arizona, USA.

- The proposed issue of the Director Placement Securities is not intended to remunerate or incentivise the Directors.
- There are no other material terms to the proposed issue of the Director Placement Securities. The Director Placement Securities will not be issued pursuant to an agreement.
- A voting exclusion statement is included in the Notice.

### **Chapter 2E of the Corporations Act**

In accordance with Chapter 2E of the Corporations Act, in order to give a financial benefit to a related party, the Company must:

- obtain Shareholder approval in the manner set out in section 217 to 227 of the Corporations Act; and
- give the benefit within 15 months following such approval,

unless the giving of the financial benefit falls within an exception set out in sections 210 to 216 of the Corporations Act.

The proposed issue of the Director Placement Securities constitutes giving a financial benefit to related parties of the Company.

The Board considers that Shareholder approval pursuant to Chapter 2E of the Corporations Act is not required in respect of the issue of the Director Placement Securities because the Securities will be issued on the same terms as those Securities issued to non-related party participants in the Placement and as such the giving of the financial benefit is on arm's length terms.

### **Additional information**

Resolution 3 is an ordinary resolution.

The non-participating Director recommends Shareholders vote in favour of Resolution 3.

## **Resolution 4 - Approval to issue 25,000,000 Lead Manager Options**

### **Background**

The background of the Placement and Lead Manager Options is set out earlier in this Explanatory Statement.

The Lead Manager to the Placement is Sanlam Private Wealth Pty Limited (Lead Manager).

Resolution 4 seeks the approval of Shareholders pursuant to and in accordance with Listing Rule 7.1 to issue the 25,000,000 Lead Managers Options.

### **Listing Rule 7.1**

A summary of Listing Rules 7.1 is set out previously in this Explanatory Statement.

The issue of Lead Managers Options does not fit within any of the exceptions to Listing Rule 7.1. It therefore requires the approval of the Company's Shareholders under Listing Rule 7.1.

The effect of Shareholders passing Resolution 4 will be to allow the Company to retain the flexibility to issue Equity Securities in the future up to the 15% placement capacity set out in Listing Rule 7.1 without the requirement to obtain prior Shareholder approval.

If Resolution 4 is passed, the Company can proceed to issue the 25,000,000 Lead Manager Options without using up any of the Company's 15% limit on issuing Equity Securities without shareholder approval under Listing Rule 7.1, effectively increasing the number of Equity Securities it can issue without Shareholder approval over the 12-month period following the issue date.

If Resolution 4 is not passed, the Company will not be able to proceed with the issue of the 25,000,000 Lead Managers Options. As at the date of this Notice, the Company does not have sufficient placement capacity to issue the 25,000,000 Lead Managers Options. Accordingly, the Company will not be able to proceed with the issue if Resolution 4 is not passed unless it has sufficient placement capacity following the Meeting.

- Lead Managers Options are being issued in consideration for lead manager services provided to the Company in relation to the Placement. Accordingly, nil cash consideration is payable for Lead Managers Options.
- A summary of the intended use of funds raised from the Placement is set out earlier in this Explanatory Statement. No additional funds will be raised by the issue of Lead Managers Options. Any funds raised upon exercise of Lead Managers Options will be used to fund exploration and drilling activities and for general working capital purposes.
- There are no other material terms to the proposed issue of Lead Managers Options.
- A voting exclusion statement is included in the Notice.

## Additional information

Resolution 4 is an ordinary resolution.

Directors recommend Shareholders vote in favour of Resolution 4.

## Resolution 5 – Adoption of Employee Securities Incentive Plan

### Background

The Company seeks Shareholder approval to adopt the Employee Securities Incentive Plan (Plan or Incentive Plan) for the purposes set out in this Explanatory Statement so that Company securities may be issued under the Incentive Plan as an exception to ASX Listing Rule 7.1.

The Plan is intended to assist the Company to attract and retain key staff, whether employees or contractors. The Board believes that grants made to eligible participants under the Plan will provide a powerful tool to underpin the Company's employment and engagement strategy, and that the Plan will:

1. enable the Company to incentivize and retain existing key management personnel and other eligible employees and contractors needed to achieve the Company's business objectives;
2. enable the Company to recruit, incentivize and retain additional key management personnel, and other eligible employees and contractors, needed to achieve the Company's business objectives;
3. link the reward of key staff with the achievement of strategic goals and the long-term performance of the Company;
4. align the financial interest of participants of the Plan with those of Shareholders; and
5. provide incentives to participants under the Plan to focus on superior performance that creates Shareholder value.

A summary of the key terms of the Plan is set out in Schedule 2 of this Notice, and a copy of the rules of the Incentive Plan is available upon request from the Company.

### ASX Listing Rules

A summary of Listing Rule 7.1 is set out previously

in this Explanatory.

Listing Rule 7.2 (Exception 13(b)) provides that Listing Rule 7.1 does not apply to an issue of securities under an employee incentive scheme, if, within three years before the date of issue of the securities, the holders of the entity's ordinary securities have approved the issue of equity securities under the scheme as an exception to Listing Rule 7.1.

Exception 13(b) is only available if and to the extent that the number of equity securities issued under the scheme does not exceed the maximum amount set out in the entity's notice of meeting dispatched to shareholders in respect of the meeting at which the shareholder approval was pursuant to Listing Rule 7.2 (Exception 13(b)). Exception 13(b) also ceases to be available if there is a material change to the terms of the scheme from those set out in the notice of meeting.

### Information required by ASX Listing Rule 14.1A

If this Resolution is approved by Shareholders for all purposes under the ASX Listing Rules, including ASX Listing Rule 7.2 (exception 13(b)), it will have the effect of enabling the securities issued by the Company under the Incentive Plan to be automatically excluded from the formula to calculate the number of securities which the Company may issue in any 12 month period using Listing Rule 7.1 (15% capacity) during the next three year period.

For the avoidance of doubt, the Company will be required to seek Shareholder approval under Listing Rule 10.14 in respect of any future issues of securities under the Incentive Plan to a related party or a person whose relationship with the Company or the related party is, in ASX's opinion, such that approval should be obtained.

If this Resolution is not passed, the Company will be able to proceed with the issue of securities under the Incentive Plan to eligible participants, but any issues of securities will reduce, to that extent, the Company's capacity to issue equity securities without Shareholder approval under Listing Rule 7.1 for the 12 month period following the issue of the securities.

### Information required by ASX Listing Rule 7.2 (exception 13(b))

Pursuant to and in accordance with Listing Rule 7.2 (Exception 13(b)), the following information is provided in relation to this Resolution:

- a) A summary of the key terms and conditions of the Incentive Plan is set out in Schedule 2 of this Notice.
- b) No Employee Incentive Plan has been previously approved by Shareholders, no Company securities have been issued under Listing Rule 7.2 (Exception 13(b)).
- c) If this Resolution is approved by Shareholders, the Company will issue up to a maximum of 74,600,000 securities under the Incentive Plan during the three-year period following approval. This maximum number includes any securities to be issued to Directors under the Incentive Plan even with Shareholder approval under Listing Rule 10.14. The maximum number is not intended to be a prediction of the actual number of Securities to be issued under the Plan, simply a ceiling for the purposes of Listing Rule 7.2 (Exception 13(b)).
- d) A voting exclusion statement is included in this Notice.

### Directors' Recommendation

The Directors recommend that Shareholders vote in favour of this Resolution.

## Resolution 6 – Approval to Issue up to \$1,000,000 worth of Shares

### Background

Resolution 6 seeks Shareholder approval pursuant to and in accordance with Listing Rule 7.1 (and for all other purposes) for the issue of that number of Shares determined by \$1,000,000 divided by the proposed Share issue price (**Proposed Shares**), (**Proposed Share Issue**).

### Listing Rule 7.1

Broadly speaking, and subject to a number of exceptions, Listing Rule 7.1 limits the amount of Equity Securities that a listed company can issue without the approval of its shareholders over any 12-month period to 15% of the fully paid ordinary shares it had on issue at the start of that period.

The issue of the Proposed Shares does not fall within any of the exceptions to Listing Rule 7.1 and, as it has not been approved by Shareholders, it effectively uses up part of the Company's 15% Placement Capacity, reducing the Company's capacity to issue further Equity Securities without Shareholder approval under Listing Rule 7.1 for the 12-month period following the issue of the Proposed Shares.

If Resolution 6 is passed, the issue of the Proposed Shares can proceed without using any of the Company's 15% Placement Capacity on issuing Equity Securities without Shareholder approval set out in Listing Rule 7.1.

If Resolution 6 is not passed, the Company will not be able to proceed with the issue of the Proposed Shares and would have to rely on the 15% and 10% (if applicable) placement capacity to have any Proposed Shares or alternate funding options to raise additional funding for its business operations described in the section below.

### Specific information required by Listing Rule 7.3

The following information in relation to Resolution 6 is provided to Shareholders for the purposes of Listing Rule 7.3:

- (a) The Directors intend that the Proposed Shares will be issued to institutional or professional and sophisticated investors and clients of Australian stockbroking firms who are not related parties of the Company. The Company has not determined who will be issued any Proposed Shares and this will be determined by the Company and its lead manager (if any) assisting with the Proposed Share Issue.

As at 30 June 2026, the Company's Non-Executive Chair, Grant Button is owed \$33,336 in Directors fees payable. He has agreed to forgive this amount payable in exchange for the issue of 3,000,000

Directors Options. In addition, approval is sought for the issue of an additional 2,000,000 Directors Options each to Grant Button and Francesco Cannavo as incentive-based remuneration.

The issue of options to directors as a form of incentive-based remuneration is common practice in listed companies and further encourages and rewards efforts by directors to improve the performance of the company to the commercial benefit of all shareholders. It further aligns with interests of the director with shareholders and allows the Company to remunerate, attract and retain experienced and qualified directors in a competitive labour market.

The Director Options are intended to provide remuneration that is linked to the performance of the Company in the future. The benefit would only be received from the Options upon the Share price exceeding the exercise price of the Options and thereby warranting their exercise before they are lapsed.

The exercise price for the Director Options will be a 50% premium to the volume weighted average price of Shares as traded on ASX over the 5 trading days prior to the date of issue. For the Directors to receive any benefit from the exercise of these Directors Options, the Company's share price as at the date of issue must increase by at least 50%.

Under the Company's current circumstances, the Directors consider that the incentive-based remuneration noted above, represented by the issue of the Director Options, is a cost effect and efficient reward and incentive to provide, as opposed to the payment of cash compensation only.

The Board believes it is important to offer these Options to continue to attract and maintain highly experienced and qualified executives and board members in a competitive market.

As at 8 July 2026, each Directors Option has been valued by the Company at an estimated value of \$0.0054 based on a market price of Shares of \$0.008, an exercise price of \$0.012 and an expiry 3 years from the date of issue. #### **Chapter 2E of the Corporations Act**

Pursuant to Chapter 2E of the Corporations Act a public company cannot give a 'financial benefit' to a 'related party' unless one of the exceptions set out in Sections 210 to 216 of the Corporations Act applies or shareholders have in a general meeting approved the giving of that financial benefit to the related party. The issue Director Options constitutes giving a financial benefit and the Directors are a related party by virtue of being a Directors of the Company.
