

EXTENSION AND EXPANSION OF DEBT FACILITY

Catapult Sports Ltd (ASX:CAT, 'Catapult' or the 'Company'), the global leader in sports technology solutions for professional teams, advises that the Company has finalized and executed documentation to extend and expand its existing debt facility with Western Alliance Bank. The existing facility, due to expire in May 2027, has been extended to May 2031 and upsized from US\$30 million to US\$50 million. This reflects a prudent and responsible approach to optimizing the Company's capital structure, and enhances the Company's flexibility to respond to potential inorganic growth opportunities.

With this extension and expansion, Catapult is in an even stronger financial position. The Company now has access to an undrawn US\$50 million debt facility, no debt, and a cash balance exceeding US\$53 million at the end of FY26. The Company has also guided to higher free cash flow for FY27, excluding transaction costs, demonstrating the strength and sustainability of its financial position.
