SaaS-based Ensign platform deployed in the US with Colorado's Radiology Imaging Associates

Ensign now live and in use by RIA through Enlitic's Intelrad integration, generating initial Annual Recurring Revenue of approximately US\$50,000

Enlitic, Inc. ("Enlitic" or the "Company") (ASX: ENL) is pleased to announce another deployment of its cloud-based, Software-as-a-Service ("SaaS") Ensign platform, which is now live and in use by Radiology Imaging Associates ("RIA") in the United States. This is the second Ensign deployment since May this year with further go lives anticipated in H2 FY26.

Based in Colorado, RIA is a physician-owned radiology group providing diagnostic and board-certified interventional radiology services through a network of imaging sites and clinical locations. The practice provides 24/7 radiologist access through its Physician Connect line and has served patients for more than 45 years.

This initial Annual Recurring Revenue ("ARR") relates to the first phase of the three-year agreement and is based on RIA's deployment of selected Ensign modules from the broader Ensign technology stack. It does not represent a full deployment of the Ensign platform across RIA's network of sites, users and workflows, which would be subject to any future expansion agreed between the parties. The initial deployment is expected to generate approximately US\$50,000 in profitable annual recurring SaaS revenue for Enlitic.

Enlitic Managing Director Michael Sistenich said: *"The first live US deployment of Ensign through our Intelrad integration is a significant milestone for Enlitic, and we are particularly pleased that Ensign is now live and in use by Radiology Imaging Associates. This deployment also demonstrates the value of our Intelrad integration, enabling Ensign to be incorporated into RIA's existing imaging environment and live radiology workflows."*

"The initial agreement and the ARR it generates are very encouraging. This ARR relates to a focused deployment of an initial subset of Ensign modules under the first phase of the three-year agreement. There will be further opportunities to consider a full deployment of the broader Ensign technology stack across RIA's network, which would represent future expansion and related revenues agreed between the parties."

"RIA operates across a network of imaging sites and clinical locations, creating a meaningful opportunity for potential expansion as additional modules, sites and use cases are considered. Our phased approach allows RIA to assess the platform's value in a live environment while providing Enlitic with a strong foundation for a broader, scalable relationship."

"Enlitic is achieving excellent commercial momentum with Ensign and the RIA agreement represents our second deployment since May of this year – a strong endorsement of the technology, but more so, a clear bellwether as to the scale we can deliver. We see further upside in ARR, primarily through securing new customer agreements through Intelrad, but also in our own right. The global demand is indeed considerable."

Darren Bullock, Chief Operating Officer, Radiology Imaging Associates, added: *"For our practice, consistency across imaging environments is critical. This integration helps strengthen how imaging studies are presented and supports a more dependable experience for our radiologists and provider partners."*

“Helping imaging data perform more reliably across existing systems is a practical priority for radiology organizations of this scale. In an environment like this, greater consistency can support stronger study presentation and reduce the need for manual adjustment.”

First live US Inteleraad-integrated deployment

Enlight has been implemented, activated and placed into operational use by RIA within the agreed initial scope. The deployment provides Enlitic with a live US customer implementation and demonstrates the Company’s ability to deliver its SaaS platform within an existing radiology workflow.

The Inteleraad integration enables Enlight to operate within RIA’s current medical imaging environment, allowing Enlitic’s technology to be incorporated without requiring a standalone replacement of RIA’s existing systems.

Enlight’s modular architecture enables customers to commence with selected capabilities and expand over time as additional sites, users, clinical workflows and modules are brought onto the platform.

Phased deployment

The current implementation covers an initial subset of Enlight modules. The initial ARR therefore reflects only the agreed first phase of deployment and does not include potential future expansion across additional modules, users or RIA sites.

Strategic importance

The deployment:

- marks Enlitic's first US Enlight deployment through the Inteleraad integration;
- validates the Company’s SaaS-based recurring revenue model;
- demonstrates the functionality of Enlitic’s Inteleraad integration;
- provides a live US customer reference;
- creates opportunities to expand across additional RIA sites and workflows; and
- establishes a foundation for future adoption of additional Enlight modules.

Enlitic will continue working with RIA to support the live deployment and assess opportunities to expand Enlight across additional sites, users, workflows and modules, subject to RIA’s requirements and agreement on applicable commercial terms.
