PATRIOT SECURES PACHAMAYO COMMUNITY AGREEMENT FOR NORTHERN TASSA SURFACE EXPLORATION

Highlights

- **Pachamayo Community authorisation received:** The Pachamayo Community has formally authorised (Patriot) Colque Perú S.A.C. to **conduct detailed geological mapping and surface sampling across the whole Community land tenure, which includes 226 Ha** in the northern portion of the Company's 100%-owned Tassa Silver-Gold Project.
- **Community Involvement:** The field program will incorporate two community-appointed guides and four local assistants from the Pachamayo Community, supporting local participation in the planned exploration activities.

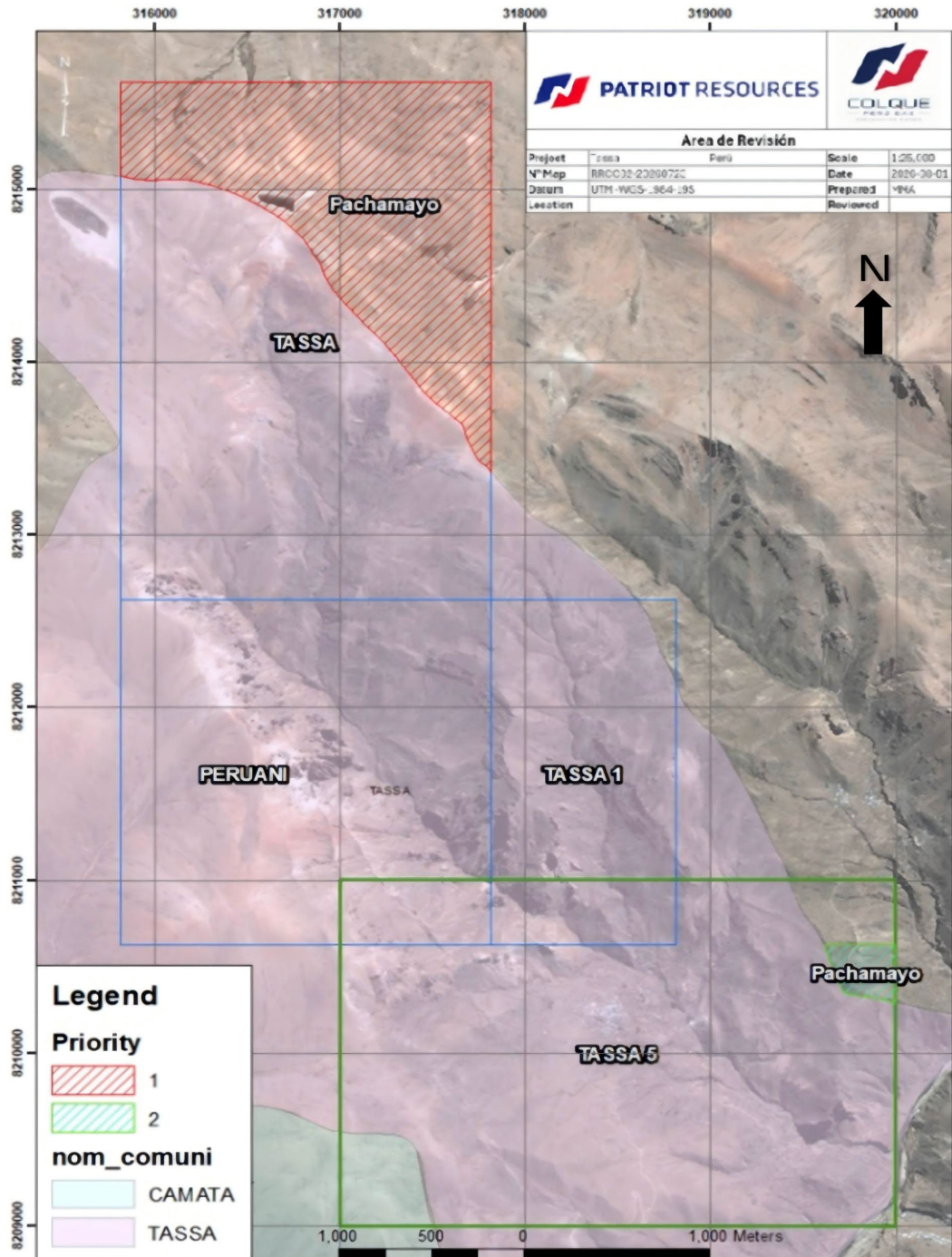


Figure 1: Authorised area for geological mapping and sampling (shown in red) in the northern portion of the 100%-owned Tassa tenement.

- **A positive first step:** The authorised area covers part of the northern area of the Tassa Project (*Figure 1*), and marks important progress in the Company's community relations program to progress exploration at the Tassa Project.
- **Further engagement continuing:** Discussions continue with the Tassa Community regarding access to other parts of the Tassa Project to support readiness for an initial drilling program.

Patriot Resources Limited (ASX: PAT) ("Patriot" or "the Company") is pleased to announce that the Pachamayo Community has formally authorised Colque Perú S.A.C., the Company's Peru-based operating team, to **conduct detailed geological mapping and sampling for an initial three-month period across the land owned by the Pachamayo Community, which includes part of the northern portion of the Company's 100%-owned Tassa Silver-Gold Project** in southern Peru. The authorised area covers part of the northern section of the Tassa Project and marks a positive and important first step. The Company thanks the Pachamayo Community for its continued collaboration and support.

Community Authorisation Secured in the North

The authorised area covers the northern portion of Patriot's 100%-owned Tassa Project and forms part of an extension of target zones identified from geophysical surveys and surface geochemical sampling completed across the licence tenure. Following the community assembly's authorisation, Colque Perú S.A.C. can now commence detailed surface mapping and sampling across this ground for an initial three-month period, to support a drill-target definition program.
