### **GOLDING AWARDED CIVIL WORKS CONTRACT AT YARRABILBA AND SHORELINE RESIDENTIAL ESTATES**

NRW Holdings Limited (ASX:NWH) is pleased to announce that its wholly owned subsidiary, Golding Contractors Pty Ltd (Golding), has been awarded contracts by Stockland Development Pty Limited (Stockland) for the delivery of civil works at the Yarrabilba and Shoreline master planned communities in Southeast Queensland.

The combined value of the contracts is approximately \$130 million with Shoreline due to be completed in July 2027 and Yarrabilba works expected to be completed by March 2028.

At Shoreline, Golding will deliver three major work packages, including the upgrade of Serpentine Creek Road with a new signalised intersection and Bebo Arch Bridge, along with subdivision and associated infrastructure works for Precincts DA7 and DA8. Located in Redland Bay approximately 43km southeast of Brisbane, when all stages are completed, Shoreline is expected to accommodate more than 10,000 residents in around 3,000 dwellings, along with a shopping precinct and state primary school.

At Yarrabilba, Golding will deliver subdivision and associated infrastructure works for Precinct 6 and Precinct 8. Located approximately 4km south of Logan Village, when all stages are completed, Yarrabilba is expected to accommodate more than 45,000 residents in approximately 17,000 dwellings, together with a town centre, neighborhood hubs and 11 schools.

Commenting on the contract awards, NRW Chief Executive Officer Jules Pemberton said "I am delighted to announce the award of these two civil works contracts. These awards further strengthen Golding's long-standing relationship with Stockland. Since we commenced working in Yarrabilba in October 2017, we have delivered more than 3,200 residential and commercial lots, providing necessary support to the Queensland housing market."
