ISSUE OF BONUS OPTIONS

Scalare Partners Holdings Limited (ASX:SCP) is pleased to announce a bonus issue to eligible shareholders of eighty seven (87) bonus unlisted options (Bonus Options) for every one hundred (100) SCP shares held at 7.00pm (AEST) on Monday 24 August 2026 for no consideration.

The Bonus Issue will be issued to all eligible shareholders with a registered address in Australia, New Zealand, Canada (Ontario and Alberta only), France, Hong Kong, India, Laos, Singapore, The United Kingdom, The United States (are institutional accredited investors within the meaning of Rule 501(a) (1), (2), (3), (7), (8), (9) or (12) under the Securities Act) and Vanuatu (Eligible Shareholders).

Each Bonus Option is convertible into one (1) ordinary share in SCP and one (1) attaching Piggyback Option (Piggyback Option), exercisable at \$0.01 per Bonus Option between 5 February 2027 and 7.00pm (AEDT) 31 March 2027. Each Piggyback Option will convert into one (1) ordinary share, exercisable at \$0.02 per Piggyback Option prior to 7.00pm (AEDT) on 31 March 2028.

Any capital raised through the exercise of Bonus Options or Piggyback Options will be used for general working capital. The Directors each intend to exercise their Bonus Options and the Piggyback Options issued on exercise of their Bonus Options.
